1 AN ACT concerning

2 Board of Education of Baltimore County - Appointment Process

3 FOR the purpose of altering the appointment process for members of the Board of

- 4 Education of Baltimore County to require that the Governor appoint a member to
- 5 the Board from a certain list submitted by the School Board Nominating
- 6 Convention of Baltimore County; making stylistic corrections; and generally relating
- 7 to the appointment process for members of the Board of Education of Baltimore
- 8 County.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

15 MARYLAND, That the Laws of Maryland read as follows:

18 (a) The BOARD OF EDUCATION OF Baltimore County [Board] consists of 1219 members who shall be appointed as follows:

20 (1) Four from the County at large;

21 (2) One from each of the seven councilmanic districts in Baltimore County;

22 and

23 (3) One student member from the County at large.

24 (B) EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION FOR THE

25 APPOINTMENT OF THE STUDENT MEMBER, EACH MEMBER APPOINTED TO THE

26 BOARD SHALL BE SELECTED FROM A LIST OF NOT MORE THAN THREE NOMINEES

27 SUBMITTED TO THE GOVERNOR BY THE SCHOOL BOARD NOMINATING

28 CONVENTION OF BALTIMORE COUNTY.

Thereafter all members shall be selected to serve 2-year terms. The initial members selected to represent legislative districts 8, 10, 12, and 13 shall each serve for a 1-year term beginning June 1, 1979, and ending May 31, 1980, and thereafter all members shall be selected for 2-year terms;		
	(3) A citizen member shall be entitled to attend and vote at a Council session where an issue before the Council concerns the school or schools in the citizen member's respective district; and		
27 28	(4) When the Council meets to consider countywide issues, all selected citizen members shall be entitled to attend such sessions and vote.		
29	[(h)] (I) The Council shall:		
	(1) Meet as needed to compile the number of spaces in the public schools of the County that are not filled and to evaluate the feasibility of the utilization of the spaces by the community and County departments; and		
33 34	(2) Report its findings and recommendations to the [County] Board [of Education] and the County Executive at least twice during the school year.		
35 36	[(i)] (J) The County Executive may, by executive order, appoint up to two additional members to the Council from agencies of the County government.
