- WHEREAS, The financing plan for the construction of a professional football
- 23 stadium at Camden Yards in Baltimore City for the Baltimore Ravens professional
- 24 football team is based in part on funding from revenues derived from State lottery
- 25 proceeds; and
- 26 WHEREAS, State lottery proceeds for the benefit of the football stadium were
- 27 originally projected to be \$32 million over Fiscal Years 1997-1999; and

WHEREAS, Because sales of lottery tickets to benefit the football stadium have remained sluggish, the State may be forced to generate additional revenues at the expense of the General Fund of the State to meet its commitment to construct the stadium; and	
WHEREAS, An alternative source of revenue to benefit the construction of the football stadium may be derived from the issuance of special vehicle registration plates to the many fans of the Baltimore Ravens professional football team throughout the State; now, therefore,

8	(2) ANY DESIGN APPROVED BY THE ADMINISTRATION, IN CONSULTATION WITH THE MARYLAND STADIUM AUTHORITY, THAT REFLECTS SUPPORT BY THE PERSON TO WHOM THE PLATE IS ISSUED FOR THE BALTIMORE RAVENS PROFESSIONAL FOOTBALL TEAM.
