A BILL ENTITLED

1 AN ACT concerning

2 **Estates and Trusts - Personal Representatives - Survival Actions**

3 FOR the purpose of providing that, in a survival action, a personal representative may
4 recover administrative costs and attorney's fees for the administration of the
5 decedent's estate and the loss of the decedent's future income during the decedent's
6 life expectancy; providing that a personal representative may not recover certain
7 economic damages to the extent that those same damages are recovered under a
8 wrongful death action by a beneficiary of the decedent; providing for the application
9 of this Act; and generally relating to certain damages in a certain legal action
10 instituted by a personal representative.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That the Laws of Maryland read as follows:

18 **Article - Estates and Trusts**

19 7-401.

20 (x) He may prosecute, defend, or submit to arbitration actions, claims, or
21 proceedings in any appropriate jurisdiction for the protection or benefit of the estate,
22 including the commencement of a personal action which the decedent might have
23 commenced or prosecuted, except that:

24 (2) In ADDITION TO OTHER DAMAGES RECOVERABLE IN THE ACTION,
25 IN an action instituted by the personal representative against a tort-feasor for a wrong
26 which resulted in the death of the decedent, the personal representative may recover,
27 EXCEPT TO THE EXTENT THAT THE SAME ECONOMIC DAMAGES ARE RECOVERED
28 UNDER § 3-904 OF THE COURTS AND JUDICIAL PROCEEDINGS ARTICLE:

29 (I) [the] THE funeral expenses of the decedent up to the amount
30 allowed under § 8-106(b) of this article [in addition to other damages recoverable in the
31 action];

1 (II) ADMINISTRATIVE COSTS AND REASONABLE ATTORNEY'S FEES
2 FOR THE ADMINISTRATION OF THE DECEDENT'S ESTATE; AND

3 (III) LOSS OF THE DECEDENT'S FUTURE EARNINGS, WAGES, AND
4 OTHER INCOME DURING THE DECEDENT'S LIFE EXPECTANCY.

5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed
6 only prospectively and may not be applied or interpreted to have any effect on or
7 application to any cause of action arising before the effective date of this Act.

8 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
9 October 1, 1997.
