A BILL ENTITLED

1 AN ACT concerning

2 Banking Institutions - Liability to Customer for Fees for Information or Documentation

- 3 FOR the purpose of providing that if a banking institution is found to be liable to a
- 4 customer in a certain action, the banking institution is liable to the customer for 10
- 5 times the amount of any fee or service charge the banking institution charged the
- 6 customer for certain information or documentation that the customer requested
- 7 relating to the action under certain circumstances; defining a certain term; and
- 8 generally relating to a banking institution's liability to a customer for certain fees or
- 9 service charges.

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 16 MARYLAND, That the Laws of Maryland read as follows:
- 17 Article Financial Institutions
- 18 5-515.
- 19 (A) IN THIS SECTION "MISHANDLING OF THE ACCOUNT OF A CUSTOMER"
- 20 INCLUDES:
- 21 (1) A VIOLATION BY A BANKING INSTITUTION OF TITLE 4 OF THE
- 22 COMMERCIAL LAW ARTICLE; OR
- 23 (2) A VIOLATION OF ANY OTHER DUTY A BANKING INSTITUTION OWES
- 24 TO A CUSTOMER IN HANDLING THE CUSTOMER'S ACCOUNT HELD BY THE BANKING
- 25 INSTITUTION.
- 26 (B) IF A BANKING INSTITUTION IS FOUND TO BE LIABLE TO A CUSTOMER IN
- 27 AN ACTION INVOLVING MISHANDLING OF THE ACCOUNT OF A CUSTOMER OF THE
- 28 BANKING INSTITUTION, AND THE BANKING INSTITUTION REQUIRED THE
- 29 CUSTOMER TO PAY A FEE OR SERVICE CHARGE FOR ANY INFORMATION OR
- 30 DOCUMENTATION THE CUSTOMER REQUESTED FROM THE BANKING INSTITUTION

- 1 WHILE INVESTIGATING HOW THE BANKING INSTITUTION HANDLED THE
- 2 CUSTOMER'S ACCOUNT OR IN PREPARING THE CUSTOMER'S CASE AGAINST THE
- 3 BANKING INSTITUTION, THE BANKING INSTITUTION SHALL BE LIABLE TO THE
- 4 CUSTOMER FOR AN AMOUNT EQUALING 10 TIMES THE AMOUNT OF THE FEE OR
- 5 SERVICE CHARGE THE BANKING INSTITUTION CHARGED THE CUSTOMER FOR THE
- 6 INFORMATION OR DOCUMENTATION, IN ADDITION TO THE DAMAGES FOR WHICH
- 7 THE BANKING INSTITUTION IS LIABLE.
- 8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 9 October 1, 1997.
