1 AN ACT concerning

2 Cigarette Business Licenses - Manufacturers and Wholesalers

3 FOR the purpose of prohibiting a licensed manufacturer of cigarettes or a person

- 4 connected to the business of a licensed manufacturer from simultaneously holding a
- 5 financial interest in a cigarette wholesaler license or wholesaler business;
- 6 prohibiting a licensed wholesaler or person connected to the business of a licensed
- 7 wholesaler from simultaneously holding a financial interest in a manufacturer
- 8 license or manufacturer business; <u>authorizing a manufacturer licensee</u>, upon
- 9 <u>approval of the State Comptroller, to act as an agent for a licensed wholesaler for</u>
- 10 stamping and distribution of cigarettes; authorizing a wholesale licensee, upon
- 11 approval of the State Comptroller, to designate a licensed manufacturer to act as its
- 12 <u>agent for the stamping and distribution of cigarettes;</u> and generally relating to
- 13 cigarette business licensing.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

20 MARYLAND, That the Laws of Maryland read as follows:

1 Article - Business Regulation

3 (a) Except as provided in subsection (b) of this section, a person must have an
4 appropriate license whenever the person acts as a manufacturer, retailer, storage
5 warehouse, subwholesaler, vending machine operator, or wholesaler in the State.

6 (b) A person need not get a retailer license to act as a retailer at a vending stand7 operated under a trader's license issued to Blind Industries and Services of Maryland.

8 (c) A license to act as a retailer is required for each place of business where a 9 person acts as a retailer.

(D) (1) A PERSON LICENSED AS A MANUFACTURER, OR PERSON
 CONNECTED WITH THE BUSINESS OF A LICENSED MANUFACTURER OR RELATED BY
 OWNERSHIP, MAY NOT AT THE SAME TIME HOLD OR HAVE ANY FINANCIAL
 INTEREST IN A WHOLESALER LICENSE OR IN ANY BUSINESS OF A WHOLESALER.

(2) A PERSON LICENSED AS A WHOLESALER, OR PERSON CONNECTED
WITH THE BUSINESS OF A LICENSED WHOLESALER OR RELATED BY OWNERSHIP,
MAY NOT AT THE SAME TIME HOLD OR HAVE ANY FINANCIAL INTEREST IN A
MANUFACTURER LICENSE OR IN ANY BUSINESS OF A MANUFACTURER.
