A BILL ENTITLED

1 AN ACT concerning

2 Maryland School for the Deaf - Funding and Services

3 FOR the purpose of requiring the Maryland School for the Deaf to establish and operate

- a program of enhanced services for deaf students who have other moderate to 4
- 5 severe disabilities; requiring the State and certain counties under certain
- 6 circumstances to share in paying the costs of the program; requiring the School and
- the Department of Education to enter into a written agreement regarding certain 7
- 8 monitoring of the School by the Department and certain assistance from the
- 9 Department to the School; authorizing certain agreements between the School and
- 10 certain other agencies; defining certain terms; establishing a formula to calculate
- 11 certain mandatory annual funding obligations for the State; including the Maryland
- 12 School for the Deaf among entities for which the Governor may not reduce
- 13 appropriations; and generally relating to the Maryland School for the Deaf.

1 Preamble WHEREAS, The Maryland School for the Deaf provides an essential service for 2 3 deaf children in the State: and 4 WHEREAS, A minimum level of funding is necessary to cover the costs of inflation 5 and enrollment growth and to ensure adequate maintenance of the School's existing 6 programs; and 7 WHEREAS, Education programs and other services to the School's students should 8 not be reduced or disrupted during the school year as a result of mid-year appropriation 9 reductions; and 10 WHEREAS, There is a need for educational services in Maryland for deaf students 11 with moderate to severe disabilities; and 12 WHEREAS, The Maryland Department of Education has the responsibility to 13 monitor the programs provided by the School; now, therefore, SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 15 MARYLAND, That the Laws of Maryland read as follows: **Article - Education** 16 17 8-310.1. 18 (A) THE MARYLAND SCHOOL FOR THE DEAF SHALL ESTABLISH AND 19 OPERATE A PROGRAM OF ENHANCED SERVICES FOR DEAF STUDENTS WHO HAVE 20 OTHER MODERATE TO SEVERE DISABILITIES. 21 (B) THE MARYLAND SCHOOL FOR THE DEAF SHALL INCLUDE A DESCRIPTION 22 OF THE PROGRAM IN THE WRITTEN AGREEMENT WITH THE DEPARTMENT OF 23 EDUCATION REQUIRED UNDER SUBSECTION (E) OF THIS SECTION. 24 (C) THE COSTS OF PROVIDING ENHANCED SERVICES TO A CHILD UNDER THE 25 PROGRAM SHALL BE PAID TO THE SCHOOL AND BE PROVIDED JOINTLY BY THE 26 STATE AND BY THE COUNTY IN WHICH THE CHILD IS DOMICILED. (D) (1) THE COUNTY IN WHICH A CHILD ENROLLED IN THE PROGRAM IS 27 28 DOMICILED SHALL PAY THE LOCAL SHARE OF THE "BASIC COST", AS DEFINED IN § 29 8-415(D)(1) OF THIS TITLE, OF THE EDUCATION FOR THAT CHILD. (2) THE STATE SHALL PAY THE REMAINING COST OF PROVIDING 30 31 SERVICES UNDER THE PROGRAM TO THE CHILD. 32 8-310.2. 33 (A) THE DEPARTMENT OF EDUCATION AND THE MARYLAND SCHOOL FOR

(B) THE AGREEMENT SHALL PROVIDE FOR MONITORING AND REVIEW BY
 THE DEPARTMENT OF THE MARYLAND SCHOOL FOR THE DEAF, INCLUDING:

37 (1) REVIEW BY THE DEPARTMENT OF THE ANNUAL BUDGET APPROVED38 BY THE BOARD OF THE MARYLAND SCHOOL FOR THE DEAF;

(2) MONITORING BY THE DEPARTMENT OF THE MARYLAND SCHOOL
 FOR THE DEAF'S PROGRAM OF ENHANCED SERVICES FOR DEAF STUDENTS WHO
 HAVE OTHER MODERATE TO SEVERE DISABILITIES, INCLUDING THE CRITERIA
 APPROVED BY THE BOARD OF THE MARYLAND SCHOOL FOR THE DEAF FOR THE
 ADMISSION OF STUDENTS TO THE PROGRAM;

6 (3) CONSULTATION BETWEEN THE DEPARTMENT AND THE MARYLAND7 SCHOOL FOR THE DEAF ON ISSUES OF DEAF EDUCATION;

8 (4) ASSISTANCE FROM THE DEPARTMENT IN DEVELOPING
9 AGREEMENTS BETWEEN THE MARYLAND SCHOOL FOR THE DEAF AND LOCAL
10 SCHOOL SYSTEMS AND OTHER STATE AND LOCAL AGENCIES FOR PROVISION OF
11 SERVICES TO DEAF CHILDREN; AND

(5) MONITORING BY AND ASSISTANCE FROM THE DEPARTMENT
 REGARDING OTHER ASPECTS OF THE MARYLAND SCHOOL FOR THE DEAF'S
 EDUCATIONAL PROGRAM AND SERVICES TO DEAF CHILDREN AS REQUIRED BY
 FEDERAL OR STATE LAW.

16 (C) THE MARYLAND SCHOOL FOR THE DEAF MAY ENTER INTO WRITTEN
17 AGREEMENTS WITH STATE AND LOCAL AGENCIES, INCLUDING LOCAL SCHOOL
18 SYSTEMS, FOR THE PURPOSE OF PROVIDING SERVICES TO DEAF CHILDREN.

20 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS 21 INDICATED.

22 (2) "FOUR-YEAR AVERAGE ANNUAL FULL-TIME EQUIVALENT23 ENROLLMENT" MEANS:

(I) THE AVERAGE NUMBER OF STUDENTS ENROLLED ANNUALLY
IN GRADES PREKINDERGARTEN THROUGH GRADE 12 AT THE MARYLAND SCHOOL
FOR THE DEAF DURING 4 CONSECUTIVE SCHOOL YEARS AS DETERMINED BY
DIVIDING THE AGGREGATE MONTHLY ENROLLMENT DURING THE 4-YEAR PERIOD
BY THE NUMBER OF MONTHS SCHOOL IS IN SESSION DURING THE 4-YEAR PERIOD;
AND

(II) ONE-HALF THE AVERAGE NUMBER OF CHILDREN SERVED
ANNUALLY BY THE MARYLAND SCHOOL FOR THE DEAF'S EARLY INTERVENTION
PROGRAM DURING 4 CONSECUTIVE SCHOOL YEARS AS DETERMINED BY DIVIDING
THE PROGRAM'S AGGREGATE MONTHLY ENROLLMENT DURING THE 4-YEAR
PERIOD BY THE NUMBER OF MONTHS SCHOOL IS IN SESSION DURING THE 4-YEAR
PERIOD.

36 (3) "GROWTH IN THE PER PUPIL BASIC CURRENT EXPENSE FIGURE"
37 MEANS THE CHANGE IN THE PER PUPIL BASIC CURRENT EXPENSE FIGURE FROM
38 THE PRIOR FISCAL YEAR TO THE CURRENT FISCAL YEAR DIVIDED BY THE PER
39 PUPIL BASIC CURRENT EXPENSE FIGURE FROM THE PRIOR FISCAL YEAR.

(4) "PER PUPIL BASIC CURRENT EXPENSE FIGURE" MEANS THE FIGURE
 CALCULATED FOR EACH FISCAL YEAR BY THE DEPARTMENT IN ACCORDANCE WITH
 § 5-202 OF THIS ARTICLE.

4 (5) "WEIGHTED ENROLLMENT GROWTH" MEANS THE PRODUCT OF 0.2
5 TIMES THE CHANGE IN THE 4-YEAR AVERAGE ANNUAL FULL-TIME EQUIVALENT
6 ENROLLMENT FROM THE 3RD THROUGH THE 6TH PRIOR SCHOOL YEARS TO THE
7 2ND THROUGH THE 5TH PRIOR SCHOOL YEARS DIVIDED BY THE 4-YEAR AVERAGE
8 ANNUAL FULL-TIME EQUIVALENT ENROLLMENT FROM THE 3RD THROUGH THE 6TH
9 PRIOR SCHOOL YEARS.

10 (B) THE MARYLAND SCHOOL FOR THE DEAF SHALL RECEIVE AN11 APPROPRIATION EQUAL TO OR GREATER THAN THE SUM OF:

12 (1) 75% OF THE PRIOR YEAR APPROPRIATION MULTIPLIED BY THE 13 PRODUCT OF:

14(I) THE SUM OF THE WEIGHTED ENROLLMENT GROWTH PLUS15 ONE; AND

16 (II) THE SUM OF THE GROWTH IN THE PER PUPIL BASIC CURRENT17 EXPENSE FIGURE PLUS ONE; AND

18 (2) 25% OF THE PRIOR YEAR APPROPRIATION MULTIPLIED BY THE SUM19 OF THE WEIGHTED ENROLLMENT GROWTH PLUS ONE.

(d) (1) In this subsection, "basic cost" as to each county, means the average
amount spent by the county from county, State, and federal sources for the public
education of a nonhandicapped child. "Basic cost" does not include amounts specifically

24 allocated and spent for identifiable compensatory programs for disadvantaged children.

(b) (1) The Governor may not reduce an appropriation to the LegislativeBranch or the Judicial Branch of the State government.

- (2) The Governor may not reduce an appropriation for:
 (i) payment of the principal of or interest on the State debt;
 (ii) public schools, INCLUDING THE MARYLAND SCHOOL FOR THE
 DEAF; or
- 33 (iii) the salary of a public officer, during the term of office.

34 (3) Except as provided in § 8-109 of the State Personnel and Pensions
35 Article, the Governor may not reduce an appropriation for the salary of any employee in
36 the classified service or unclassified service.

37 SECTION 2. AND BE IT FURTHER ENACTED, That:

1 (a) The provisions of this Act relating to the formula for determining annual 2 appropriations for the Maryland School for the Deaf may not be implemented until the 3 fiscal year beginning on July 1, 1998.

4 (b) The provisions of this Act relating to funding for the program of enhanced
5 services for deaf students who have other moderate to severe disabilities created in §
6 8-310.1 of the Education Article shall be implemented for the fiscal year beginning on
7 July 1, 1997.

8 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 9 July 1, 1997.
