1 AN ACT concerning

2 Nonprofit Organizations - Operating Assistance and Performance Funding Grants

- 3 FOR the purpose of altering provisions and establishing new provisions that relate to
- 4 operating assistance and performance funding grants for housing assistance;
- 5 requiring the Department of Housing and Community Development to award
- 6 performance funding grants to certain nonprofit organizations for certain purposes;
- 7 establishing certain criteria for eligibility for a performance funding grant; requiring
- 8 a nonprofit organization receiving a performance funding grant to provide certain
- 9 matching funds; authorizing a nonprofit organization to use funding grants under
- this Act for certain purposes; altering the maximum percentage of certain funds
- from which grants are made; repealing the abrogation provision for certain housing
- assistance grants programs; defining certain terms; making certain stylistic changes;
- and generally relating to low-income housing funding grants for nonprofit

- 30 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 31 MARYLAND, That the Laws of Maryland read as follows:

- 4 (b) "Homeownership Programs Fund" means that fund referred to in §§ 2-613(a) 5 and 2-1006(a) of this title.
- 6 (c) "Nonprofit organization" means a corporation, foundation, or other legal 7 entity, no part of the net earnings of which inures to the benefit of any private
- 8 shareholder or individual holding any interest in such entity.
- 9 (D) "HOUSING PRODUCTION" MEANS THE ACQUISITION, CONSTRUCTION, OR 10 REHABILITATION OF HOUSING FOR OCCUPANCY BY OR SALE TO LOW AND
- 11 MODERATE INCOME HOUSEHOLDS.
- 12 [(d)] (E) "Operating assistance grants" means assistance with operating and
- 13 overhead costs of a nonprofit organization, including staff costs, organizational costs, and,
- 14 in the case of grants under § 2-1203 of this subtitle, costs relating to applying for a loan
- 15 or assisting individuals in applying for a loan THAT RELATES TO AREAS OF UNMET
- 16 NEED, AS DEFINED BY THE DEPARTMENT, FOR LOW-INCOME HOUSING.
- 17 (F) "PERFORMANCE FUNDING GRANTS" MEANS ASSISTANCE WITH
- 18 PREDEVELOPMENT COSTS AND OPERATING AND OVERHEAD COSTS OF A
- 19 NONPROFIT ORGANIZATION, INCLUDING STAFF COSTS AND ORGANIZATIONAL
- 20 COSTS.
- 21 [(e)] (G) "Rental Housing Programs Fund" means that fund referred to in §§
- 22 2-313(a), 2-505(a), and 2-805(a) of this title.
- 23 [(f)] (H) "Special Loan Programs Fund" means that fund referred to in §
- 24 2-708(a) of this title.

- 26 (a) The Department[, under a demonstration project,] shall [make] AWARD
- 27 operating assistance grants to nonprofit organizations for the purpose of building their
- 28 capacity to participate in housing projects or activities authorized by the programs
- 29 established in this title that are financed through the Rental Housing Programs Fund, the
- 30 Homeownership Programs Fund, the Special Loan Programs Fund, or otherwise financed
- 31 in whole or in part by the Department.
- 32 (b) To be eligible for an operating assistance grant under this section a nonprofit
- 33 organization must have limited expertise or no recent experience in participating in
- 34 projects or activities financed in whole or in part by the Department.

	(i) Completed, or substantially completed, a loan application that has been deemed acceptable by the Department to undertake a housing project which is financed, in whole or in part, by the Department; or

14	(A) THE DEPARTMENT SHALL AWARD PERFORMANCE FUNDING GRANTS TO NONPROFIT ORGANIZATIONS FOR THE PURPOSE OF ENABLING ELIGIBLE NONPROFIT ORGANIZATIONS TO ENGAGE IN HOUSING PRODUCTION FOR LOW AND MODERATE INCOME HOUSEHOLDS.

- 4 (B) A NONPROFIT ORGANIZATION RECEIVING A PERFORMANCE FUNDING
- 5 GRANT FROM THE DEPARTMENT MUST PROVIDE MATCHING FUNDS IN AN AMOUNT
- 6 NOT LESS THAN 50 PERCENT OF THE AMOUNT OF THE PERFORMANCE FUNDING
- 7 GRANT RECEIVED.
- 8 (C) OPERATING ASSISTANCE AND PERFORMANCE FUNDING GRANTS MAY BE
- 9 USED BY AND AT THE DISCRETION OF THE NONPROFIT ORGANIZATION FOR
- 10 ADMINISTRATIVE AND OPERATING EXPENSES, ORGANIZATIONAL COSTS, AND
- 11 OTHER COSTS ASSOCIATED WITH THE PRODUCTION OF HOUSING.
- 12 [(b)] (D) Subject to § 2-1202 of this subtitle, a nonprofit organization may receive
- 13 a grant or grants, for up to 3 years for capacity building purposes in each of the housing
- 14 development areas of rental housing programs, home ownership programs, and special
- 15 loan programs.
- [(c)] (E) A grant made under § 2-1202 of this subtitle may be for a term of up to
- 17 3 years if, in the determination of the Department, the performance of the nonprofit
- 18 organization in the preceding year is acceptable and funds are appropriated and available
- 19 in the succeeding year.
- 20 (F) SUBJECT TO § 2-1203.1 OF THIS SUBTITLE, A NONPROFIT ORGANIZATION
- 21 MAY RECEIVE PERFORMANCE FUNDING GRANTS, EACH GRANT HAVING A TERM OF
- 22 UP TO 3 YEARS IN EACH OF THE HOUSING DEVELOPMENT AREAS OF RENTAL
- 23 HOUSING PROGRAMS, HOMEOWNERSHIP PROGRAMS, AND SPECIAL LOAN
- 24 PROGRAMS FOR AS LONG AS THE DEPARTMENT DETERMINES THAT THE
- 25 NONPROFIT ORGANIZATION IS IN NEED OF ASSISTANCE WITH OPERATING COSTS,
- 26 HAS SUSTAINED PERFORMANCE, AND HAS MET THE GOALS IN THE ORGANIZATION'S
- 27 ANNUAL WORK PROGRAM.
- [(d)] (G) During any fiscal year, the total amount of all operating assistance AND
- 29 PERFORMANCE FUNDING grants made under this subtitle shall be made from, and may
- 30 not exceed [1] 2 percent of the total aggregate amount of budgeted moneys in the Rental
- 31 Housing Programs Fund, Homeownership Programs Fund, and Special Loan Programs
- 32 Fund.
