SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 19

20 MARYLAND, That Section(s) 8-901 and the subtitle "Subtitle 9. Revitalization

- 21 Districts", respectively, of Article 2B Alcoholic Beverages of the Annotated Code of
- 22 Maryland be renumbered to be Section(s) 8-1001 and the subtitle "Subtitle 10.
- 23 Revitalization Districts", respectively.

24 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland 25 read as follows:

- 26 Article 2B - Alcoholic Beverages
- 27 SUBTITLE 9. BEER TASTING LICENSES.
- 28 8-901.
- 29 (A) THIS SECTION APPLIES ONLY IN CARROLL COUNTY.

1 (B) IN THIS SECTION, "BOARD" MEANS THE BOARD OF LICENSE 2 COMMISSIONERS.

3 (C) THE BOARD MAY APPROVE THE ISSUANCE OF A BEER TASTING (BT)4 ALCOHOLIC BEVERAGES LICENSE.

5 (D) THE LICENSE MAY BE ISSUED ONLY TO HOLDERS OF A BEER, WINE AND 6 LIQUOR (BWL) OR A BEER AND WINE (BW) LICENSE.

7 (E) THE LICENSE PERMITS THE CONSUMPTION OF BEER AUTHORIZED TO BE
8 SOLD BY THE BEER, WINE AND LIQUOR LICENSE (BWL) OR THE BEER AND WINE
9 LICENSE (BW) FOR TASTING OR SAMPLING PURPOSES ONLY. CONSIDERATION MAY
10 NOT BE CHARGED OR EXACTED.

11 (F) THE BOARD SHALL REGULATE:

12 (1) THE QUANTITY OF BEER TO BE SERVED TO EACH PERSON;

13 (2) THE NUMBER OF BOTTLES OR OTHER CONTAINERS OF BEER FROM14 WHICH THIS QUANTITY IS BEING SERVED; AND

15 (3) THE SIZE OF THE BOTTLES OR OTHER CONTAINERS.

16 (G) THE ANNUAL LICENSE FEE:

17 (1) FOR HOLDERS OF A BWL LICENSE IS \$100 IN ADDITION TO THE COST18 OF THE BWL LICENSE; AND

19 (2) FOR HOLDERS OF A BW LICENSE IS \$100 IN ADDITION TO THE COST20 OF THE BW LICENSE.

21 (H) THE PRIVILEGES GRANTED BY THIS BEER TASTING LICENSE MAY NOT BE22 EXERCISED DURING THE MARYLAND WINE FESTIVAL.

23 (I) THE BOARD MAY ADOPT REGULATIONS PROVIDING ADDITIONAL24 REQUIREMENTS TO IMPLEMENT THIS SECTION.

25 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 26 October 1, 1997.
