- 8 (A) A FOOD SERVICE FACILITY SHALL POST OR OTHERWISE MAKE 9 AVAILABLE TO ITS EMPLOYEES A LIST OF ALL THE INGREDIENTS OF EACH 10 PREPARED FOOD ITEM THAT IT SELLS OR SERVES.
- 11 (B) A FOOD SERVICE FACILITY SHALL TRAIN ITS EMPLOYEES TO INFORM 12 CUSTOMERS, UPON REQUEST, OF THE INGREDIENTS IN EACH PREPARED FOOD ITEM 13 THAT IT SELLS OR SERVES.
