15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

16 MARYLAND, That the Laws of Maryland read as follows:

- 21 (2) (I) "RESOURCE" MEANS ANY ASSET OR SERVICE THAT A PUBLIC

- 23 1. MAKES AVAILABLE TO OR SELLS TO ANY OF ITS
- 24 NONREGULATED SUBSIDIARIES; OR
- 25 2. SPECIFIES IN ITS COST ALLOCATION MANUAL.
- 26 (II) "RESOURCE" INCLUDES, BUT IS NOT LIMITED TO:
- 27 1. MAILING LISTS;
- 28 2. TELEPHONE REFERRALS/CUSTOMER REFERRALS;

6	(B) THIS SECTION APPLIES TO A PUBLIC SERVICE COMPANY THAT:
