# 1 AN ACT concerning

## 2 Worcester County - Recording and Indexing

- 3 FOR the purpose of repealing a requirement that the Clerk of the Circuit Court of
- 4 Worcester County record and index ordinances, resolutions, and regulations; and
- 5 generally relating to recording and indexing ordinances, resolutions, and regulations
- 6 in Worcester County.
- 7 BY repealing and reenacting, with amendments,

- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 13 MARYLAND, That the Laws of Maryland read as follows:

## 14 Article 25 - County Commissioners

- 16 (a) A copy of all acts, ordinances, and resolutions adopted or passed by the
- 17 county commissioners of any county under the authority of § 3 of this article, certified by
- 18 the president of the board of county commissioners and attested by the clerk to said
- 19 board, shall be filed with the clerk of the court of said county, who shall record, date, and
- 20 index the same without charge in a volume to be provided for the purpose by the county
- 21 commissioners.
- 22 (b) An act, ordinance, or resolution adopted or passed by the county
- 23 commissioners of any county under the authority of § 3 of this article may not become
- 24 effective until a copy thereof has been filed with the clerk of the court of the county, and
- 25 a fair summary of the act, ordinance, or resolution has been published, after adoption or
- 26 passage, in at least one newspaper of general circulation in the county. Any act,
- 27 ordinance, or resolution filed as herein required, shall be admissible as evidence in any
- 28 court proceeding upon certification by the said clerk of the court.
- 29 (c) The Clerk of the Circuit Court of Dorchester County shall record and index
- 30 all ordinances, resolutions, and regulations adopted by the Board of County

- 1 Commissioners of Dorchester County and there shall be no charge to the County for the 2 recording and indexing thereof.
- 3 [(d) The Clerk of the Circuit Court of Worcester County shall record and index all 4 ordinances, resolutions, and regulations adopted by the Board of County Commissioners
- 5 of Worcester County, and there shall be no charge to the County for the recording and
- 6 indexing thereof.]
- 7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 8 October 1, 1997.
