- 3 FOR the purpose of increasing the salary of the members of the Board of County
- 4 Commissioners for Calvert County, the Sheriff of Calvert County, and the Judges of
- 5 the Orphans' Court for Calvert County; providing certain limitations on
- 6 reimbursements for certain expenses by County Commissioners; providing that this

- 26 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 27 MARYLAND, That the Laws of Maryland read as follows:

- 3 Five county commissioners comprise the Board of County Commissioners of Calvert
- 4 County. The annual salary of the president of the board is [\$27,500] \$32,500, and the
- 5 annual salary of each of the associate members of the board is [\$25,000] \$30,000. EACH
- 6 COMMISSIONER MAY BE REIMBURSED UP TO AN ANNUAL TOTAL OF \$2,000, FOR ANY
- 7 REASONABLE COSTS INCURRED BY THE COMMISSIONER IN CARRYING OUT THE
- 8 FUNCTIONS OF THE OFFICE.

- 11 (f) (1) The Sheriff of Calvert County shall receive an annual salary of 12 [\$48,000] \$51,000.
- 13 Article Estates and Trusts

- 15 (f) Each of the judges of the Court for Calvert County shall receive as annual
- 16 compensation the sum of [\$4,500] \$5,000. The salary of the Chief Judge is [\$4,700]
- 17 \$5,200. The County Commissioners may provide additional funds for expenses for the
- 18 judges. ANY COST OF LIVING ADJUSTMENT APPLIED TO THE SALARIES OF CALVERT
- 19 COUNTY EMPLOYEES SHALL BE EQUALLY APPLIED TO THE SALARIES OF THE
- 20 JUDGES.
- 21 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III,
- 22 Section 35 of the Constitution of Maryland, this Act may not be construed to extend or
- 23 apply to the salary or compensation of the Board of County Commissioners of Calvert
- 24 County, the Sheriff of Calvert County, or the Judges of the Orphans' Court for Calvert
- 25 County in office on the effective date of this Act, but the provisions of this Act concerning
- 26 the salary or compensation of the Board of County Commissioners of Calvert County, the
- 27 Sheriff of Calvert County, and the Judges of the Orphans' Court for Calvert County shall
- 28 take effect at the beginning of the next following term of office.
- 29 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 30 October 1, 1997.
