1 AN ACT concerning

2 **Calvert County - Board of County Commissioners, Sheriff, and Judges - Salaries**

3 FOR the purpose of increasing the salary of the members of the Board of County
4 Commissioners for Calvert County, the Sheriff of Calvert County, and the Judges of
5 the Orphans' Court for Calvert County; providing ~~certain limitations on~~
6 ~~reimbursements for~~ reimbursement of certain expenses incurred by the County
7 Commissioners up to a specified cap; providing that this Act does not apply to the
8 salaries or compensation of the incumbents in those offices; and generally relating
9 to salaries of the Calvert County Commissioners, Sheriff, and Judges.

2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
3 MARYLAND, That the Laws of Maryland read as follows:

4 **Article 5 - Calvert County**

5 2-101.

6 Five county commissioners comprise the Board of County Commissioners of Calvert
7 County. The annual salary of the president of the board is [\$27,500] \$32,500, and the
8 annual salary of each of the associate members of the board is [\$25,000] \$30,000. EACH
9 COMMISSIONER MAY BE REIMBURSED UP TO AN ANNUAL TOTAL OF \$2,000, FOR ANY
10 REASONABLE COSTS INCURRED BY THE COMMISSIONER IN CARRYING OUT THE
11 FUNCTIONS OF THE OFFICE.

12 **Article - Courts and Judicial Proceedings**

14 (f) (1) The Sheriff of Calvert County shall receive an annual salary of
15 [\$48,000] \$51,000.

16 **Article - Estates and Trusts**

17 2-108.

18 (f) Each of the judges of the Court for Calvert County shall receive as annual
19 compensation the sum of [\$4,500] \$5,000. The salary of the Chief Judge is [\$4,700]
20 \$5,200. The County Commissioners may provide additional funds for expenses for the
21 judges. ~~ANY COST OF LIVING ADJUSTMENT APPLIED TO THE SALARIES OF CALVERT~~
22 ~~COUNTY EMPLOYEES SHALL BE EQUALLY APPLIED TO THE SALARIES OF THE~~
23 ~~JUDGES.~~

24 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III,
25 Section 35 of the Constitution of Maryland, this Act may not be construed to extend or
26 apply to the salary or compensation of the Board of County Commissioners of Calvert
27 County, the Sheriff of Calvert County, or the Judges of the Orphans' Court for Calvert
28 County in office on the effective date of this Act, but the provisions of this Act concerning
29 the salary or compensation of the Board of County Commissioners of Calvert County, the
30 Sheriff of Calvert County, and the Judges of the Orphans' Court for Calvert County shall
31 take effect at the beginning of the next following term of office.

32 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
33 October 1, 1997.
