## 1 AN ACT concerning

## 2 Charles County - County Officials - Salaries and Expenses

- 3 FOR the purpose of increasing the salaries of the Charles County Commissioners and the
- 4 Charles County Treasurer beginning at a certain time; providing for the increase in
- 5 expenses of the Charles County School Board Chairman at a certain time; providing
- 6 that this Act does not apply to the salary or compensation of the incumbent
- 7 members of the Charles County Commissioners, Chairman of the Board of
- 8 Education, or the Treasurer; and generally relating to the increase in salary and
- 9 expenses for certain Charles County officials.

- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 21 MARYLAND, That the Laws of Maryland read as follows:

- 3 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III,
- 4 Section 35 of the Constitution of Maryland, this Act may not be construed to extend or
- 5 apply to the salary or compensation of the County Commissioners of Charles County, the
- 6 <u>Chairman of the Charles County Board of Education</u>, or the Treasurer for Charles
- 7 County in office on the effective date of this Act, but the provisions of this Act concerning
- 8 the salary or compensation of the County Commissioners of Charles County, the
- 9 <u>Chairman of the Charles County Board of Education</u>, or Treasurer of Charles County
- 10 shall take effect at the beginning of the next following term of office.
- 11 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 12 October 1, 1997.
