| | SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: |
| 16 17 | Article - Health Occupations 19-302. |
| 18 | (d) (1) An applicant for a certified social worker license shall have: |
| | (i) A master's degree from an accredited college or university and based on a graduate social work program accredited by the Council on Social Work Education; and |
| 24 | (ii) 2 years of social work experience as a social worker where face-to-face supervision is part of the employment contract and the supervisor is a licensed certified social worker and is provided by and accountable to the employer after receiving the master's degree. |

13 Until January 1, [1995] 1999, the Board shall waive the examination requirements 14 of this title for an applicant for a certified social worker-clinical license if the applicant:

(1) Pays the application fee required by the Board under § 19-303 of thissubtitle;

17 (2) Was a licensed certified social worker on July 1, 1993; and

(3) Was eligible for inclusion on the vendorship list maintained by the Boardon July 1, 1993.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed 21 retroactively and shall be applied to and interpreted to affect applicants who applied on 22 or after January 1, 1995.

23 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 24 October 1, 1997.
