- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 23 (2) UNLESS THE ZONING ORDINANCE OF A JURISDICTION

- 2 (a) Except as provided in §§ 3.05(a)(1)(iii), (v), (vi), and (viii), (4), and (b),
- 3 3.06(b) and (c), 4.01(a)(2) AND (E), 4.09, 5.03(e), 7.01(c), 10.01, 11.01, 12.01, and 13.01 of
- 4 this article, and subject to subsection (b) of this section, this article does not apply to the
- 5 chartered counties of Maryland. This section supersedes § 7.02 of this article and any
- 6 inconsistent provision of Article 28 of the Code.
- 7 (b) Section 13.01 of this article does not apply to Montgomery County or Prince 8 George's County.
- 9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed
- 10 only prospectively and may not be applied or interpreted to have any effect on or
- 11 application to any pawn shop in existence and permitted by a jurisdiction before the
- 12 effective date of this Act.
- 13 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 14 October 1, 1997.
