A BILL ENTITLED

1 AN ACT concerning

2 Baltimore City Community College - Creation of Positions

- 3 FOR the purpose of authorizing the Board of Trustees of Baltimore City Community
- 4 College to create positions subject to certain conditions; requiring the Board to
- 5 submit a certain annual report to the Department of Budget and Management, the
- 6 Department of Fiscal Services, and the Maryland Higher Education Commission;
- 7 requiring that certain positions authorized under certain provisions be limited as
- 8 specified annually in the State budget bill; providing a certain effective date for
- 9 certain authority to create positions under this Act; requiring the Board of Trustees
- 10 to provide a certain report to the Legislative Policy Committee by a certain date;
- providing for the application of this Act; and generally relating to the Board's
- 12 authority to create positions.

- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 19 MARYLAND, That the Laws of Maryland read as follows:
- 20 Article Education
- 21 16-505.
- 22 (h) (3) (I) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE
- 23 BOARD OF TRUSTEES MAY CREATE ANY POSITION TO THE EXTENT THAT THE COST
- 24 OF THE POSITION, INCLUDING ANY FRINGE BENEFIT COSTS, IS FUNDED FROM
- 25 GRANT OR SPECIAL PROJECT FUNDS.
- 26 (II) THIS PARAGRAPH MAY NOT BE CONSTRUED TO REQUIRE ANY
- 27 ADDITIONAL STATE GENERAL FUND SUPPORT.
- 28 (III) BY SEPTEMBER 1 OF EACH YEAR, THE BOARD SHALL SUBMIT
- 29 AN ANNUAL POSITION ACCOUNTABILITY REPORT TO THE DEPARTMENT OF BUDGET

- 1 AND MANAGEMENT, THE DEPARTMENT OF FISCAL SERVICES, AND THE MARYLAND
- 2 HIGHER EDUCATION COMMISSION REPORTING THE TOTAL POSITIONS CREATED
- 3 AND THE COST AND THE FUNDING SOURCE FOR ANY POSITIONS CREATED BY
- 4 BALTIMORE CITY COMMUNITY COLLEGE IN THE PREVIOUS FISCAL YEAR.
- 5 (IV) THE TOTAL NUMBER OF POSITIONS AUTHORIZED UNDER THIS 6 PARAGRAPH SHALL BE LIMITED AS SPECIFIED ANNUALLY IN THE STATE BUDGET 7 BILL.
- 8 SECTION 2. AND BE IT FURTHER ENACTED, That, in addition to the
- 9 reporting requirements specified in § 16-505(h)(3) of the Education Article, the Board of
- 10 Trustees shall provide a report by September 1, 1999, in accordance with § 2-1312 of the
- 11 State Government Article, to the Legislative Policy Committee on the financing of the
- 12 created positions, including the manner in which wages and fringe benefits costs are
- 13 supported by general and nongeneral funds.
- 14 SECTION 3. AND BE IT FURTHER ENACTED, That the provisions of this
- 15 Act granting authority to create positions shall be effective beginning with Fiscal Year 16 1998.
- 17 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect 18 July 1, 1997.
