2 State Police Retirement System - Death Benefits

- 3 FOR the purpose of providing that for certain deceased members of the State Police
- 4 Retirement System, any allowance paid to the surviving spouse is to be based on an
- 5 average final compensation in a certain manner; providing for the construction of
- 6 this Act; and generally relating to death benefits for members of the State Police
- 7 Retirement System.
- 8 BY repealing and reenacting, without amendments,
- 9 Article State Personnel and Pensions

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

14 MARYLAND, That the Laws of Maryland read as follows:

15 Article - State Personnel and Pensions

16 29-204.

- 17 (a) This section applies only to an individual who dies while employed as a
- 18 member of the State Police Retirement System:
- 19 (1) without willful negligence by the member; and
- 20 (2) (i) with more than 2 years of eligibility service; or
- 21 (ii) with death arising out of or in the course of the actual performance
- 22 of duty.
- 23 (b) When the Board of Trustees receives proof of death of a member and finds
- 24 that the death has occurred in the manner described in subsection (a) of this section, the
- 25 Board of Trustees shall pay:
- 26 (1) if the member is survived by a spouse, a child under the age of 18 years,
- 27 or a dependent parent:
- 28 (i) the member's accumulated contributions to the designated
- 29 beneficiary, or otherwise to the member's estate; and

2 1 (ii) an allowance of 50% of the member's average final compensation: 2 1. to the surviving spouse; 3 2. if there is no surviving spouse or if the surviving spouse dies 4 before the youngest child of the member is 18 years old, to all children under the age of 5 18 years; or 6 3. if there is no surviving spouse or children younger than 18 7 years of age, to the member's dependent parent to continue as the Board of Trustees may 8 direct for the rest of the parent's life; or 9 (2) if the member is not survived by a spouse, a child under the age of 18 10 years, or a dependent parent, the death benefit under § 29-202 of this subtitle. 11 (c) If the Board of Trustees pays an allowance under this section to more than 12 one child, the Board of Trustees shall divide the allowance among the children under the 13 age of 18 years in a manner that provides for payments to continue until each child dies 14 or becomes 18 years old. SECTION 2. AND BE IT FURTHER ENACTED, That: 15 (1) For members of the State Police Retirement System whose death arose 16 17 out of or in the course of the actual performance of duty during the period July 1, 1992 18 through June 30, 1996, any allowance paid to the surviving spouse under § 29-204 of the 19 State Personnel and Pensions Article shall be based on an average final compensation 20 that is computed to include the next annual step increment that the deceased members 21 would have been entitled to if their death had not occurred and any annual step 22 increments that the deceased members were denied in Fiscal Year 1992 and Fiscal Year 23 1993; and 24 (2) The computation of any allowances under this Act shall be effective

25 prospectively only from the effective date of this Act and may not be construed to

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect

26 authorize any retroactive death benefit or salary adjustment.
