13	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 M	ARYLAND, That the Laws of Maryland read as follows:
15	Article - Transportation
16 13	-903.
17	(a) The following vehicles are exempt from the registration fees specified in this
18 sul	btitle:

(1) A vehicle that is owned and operated by the United States, this State, or

1 (2) A vehicle that is owned by a volunteer fire company incorporated in this 2 State or by a rescue squad and that is used for fire-fighting or ambulance purposes;
3 (3) A canteen wagon of a recognized fire buff organization, as certified by 4 the International Fire Buffs Association;
5 (4) A vehicle owned and operated by the Civil Air Patrol;
6 (5) A vehicle owned and operated by a unit of a national veterans' 7 organization;
8 (6) A vehicle owned and operated by a Maryland chapter of the American 9 Red Cross;
10 (7) A motor vehicle and trailer known as the "40-8 box car" that is owned 11 and operated only for social or charitable purposes by any voiture of the Forty and Eight 12 of the American Legion, Department of Maryland;
13 (8) A vehicle owned and personally used by a veteran who:
14 (i) As designated or classified by the Veterans' Administration, has 15 lost the use of a hand, arm, or leg, or is totally disabled; or
16 (ii) Has a permanent impairment of both eyes so that:
17 1. The central visual acuity is 20/200 or less in the better eye, with corrective glasses; or
2. There is a field defect in which the peripheral field has contracted to such an extent that the widest diameter of visual field subtends an angular distance no greater than 20 degrees in the better eye; and
22 (9) A Type I or Type II school vehicle owned and operated by a religious 23 organization.
24 (b) The Administration may exempt from the registration fees specified in this 25 subtitle any vehicle of a law enforcement agency of the United States or of any other 26 state, if the United States or other state provides a reciprocal exemption for law 27 enforcement vehicles of this State.
28 (c) (1) Each registered vehicle that is exempt from registration fees under 29 subsection (a) of this section shall display a special identification marker approved by the 30 Administrator.
31 (2) The special identification marker for a motor vehicle and trailer exempt 32 under subsection (a)(7) of this section shall bear the number of the organization and the 33 number of the local voiture, reading "40-8-(local number)".
34 (3) The special identification marker for a vehicle exempt under subsection 35 (a)(8)(i) of this section shall indicate that the Veterans' Administration has designated or 36 classified the veteran as having lost the use of a hand, arm, or leg or as being totally 37 disabled.

- 1 (d) [Any] A disabled veteran whose vehicle is eligible for exemption under 2 subsection (a)(8) of this section [and who also is eligible for a special, disabled persons 3 registration number under § 13-616 of this title] may [elect to], IF ELIGIBLE, receive the
- 4 special registration number and special registration plates provided [for in that section,]
- 5 UNDER § 13-616, § 13-619, OR § 13-619.1 OF THIS TITLE without payment of the
- 6 registration fees specified in this subtitle.
- 7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 8 October 1, 1997.
