A BILL ENTITLED

1 AN ACT concerning

2 Baltimore City Community College - Creation of Positions

- 3 FOR the purpose of authorizing the Board of Trustees of the Baltimore City Community
- 4 College to create positions subject to certain conditions; requiring the Board to
- 5 submit a certain annual report to the Department of Budget and Management, the
- 6 Department of Fiscal Services, and the Maryland Higher Education Commission;
- 7 requiring that certain positions authorized under certain provisions be limited as
- 8 specified annually in the budget bill; providing a certain effective date for certain
- 9 authority to create positions under this Act; requiring the Board of Trustees to
- provide a certain report to the Legislative Policy Committee by a certain date; and
- 11 generally relating to the authority of the Board of Trustees of the Baltimore City
- 12 Community College to create positions.

- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 19 MARYLAND, That the Laws of Maryland read as follows:
- 20 Article Education
- 21 16-505.
- 22 (h) (3) (I) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE
- 23 BOARD OF TRUSTEES MAY CREATE ANY POSITION IN THE COLLEGE TO THE EXTENT
- 24 THAT THE COST OF THE POSITION, INCLUDING THE COST OF ANY FRINGE BENEFITS,
- 25 IS FUNDED FROM GRANT OR SPECIAL PROJECT FUNDS.
- 26 (II) THIS PARAGRAPH MAY NOT BE CONSTRUED TO REQUIRE ANY
- 27 ADDITIONAL STATE GENERAL FUND SUPPORT.
- 28 (III) BY SEPTEMBER 1 OF EACH YEAR, THE BOARD SHALL SUBMIT
- 29 AN ANNUAL POSITION ACCOUNTABILITY REPORT TO THE DEPARTMENT OF BUDGET
- 30 AND MANAGEMENT, THE DEPARTMENT OF FISCAL SERVICES, AND THE COMMISSION
- 31 THAT INCLUDES INFORMATION ON:

1	1. THE TOTAL POSITIONS CREATED BY THE COLLEGE IN
2	THE PREVIOUS FISCAL YEAR; AND

- 3 2. THE COST AND FUNDING SOURCE FOR ANY POSITIONS
- 4 CREATED BY THE COLLEGE IN THE PREVIOUS FISCAL YEAR.
- 5 SECTION 2. AND BE IT FURTHER ENACTED, That, in addition to the
- 6 reporting requirements set forth in § 16-505(h)(3) of the Education Article, the Board of
- 7 Trustees shall provide a report by September 1, 1999, in accordance with § 2-1312 of the
- 8 State Government Article, to the Legislative Policy Committee on the financing of the
- 9 created positions, including the manner in which the costs of wages and fringe benefits
- 10 are supported by general and nongeneral funds.
- SECTION 3. AND BE IT FURTHER ENACTED, That the provisions of this Act
- 12 granting authority to create positions shall be effective beginning with Fiscal Year 1998.
- 13 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect 14 July 1, 1997.
