- 4 FOR the purpose of requiring certain insurers, nonprofit health service plans, and health
  5 maintenance organizations to provide a certain minimum length of inpatient
  6 hospitalization coverage after a mastectomy or lymph node dissection that is
  7 performed for the treatment of breast cancer; requiring that insurers, nonprofit
  8 health service plans, and health maintenance organizations provide coverage for
  9 home visits under certain circumstances; requiring certain persons to provide a
  10 certain notice; providing for the application of this Act; defining a certain term; and
  11 generally relating to requiring certain insurers, nonprofit health service plans, and
- health maintenance organizations to provide a certain minimum length of inpatient
- 13 hospitalization coverage after a mastectomy or lymph node dissection under certain

- 3 (A) IN THIS SECTION, "MASTECTOMY" MEANS THE SURGICAL REMOVAL OF 4 ALL OR PART OF A BREAST AS A RESULT OF BREAST CANCER.
- 5 (B) THIS SECTION APPLIES TO:
- 6 (1) INSURERS AND NONPROFIT HEALTH SERVICE PLANS THAT PROVIDE
- 7 INPATIENT HOSPITAL, MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR
- 8 GROUPS ON AN EXPENSE-INCURRED BASIS UNDER HEALTH INSURANCE POLICIES
- 9 OR CONTRACTS THAT ARE ISSUED OR DELIVERED IN THE STATE; AND
- 10 (2) HEALTH MAINTENANCE ORGANIZATIONS THAT PROVIDE
- 11 INPATIENT HOSPITAL, MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR
- 12 GROUPS UNDER CONTRACTS THAT ARE ISSUED OR DELIVERED IN THE STATE.
- 13 (C) AN ENTITY SUBJECT TO THIS SECTION SHALL PROVIDE COVERAGE FOR 14 THE COST OF INPATIENT HOSPITALIZATION SERVICES FOR A MINIMUM OF:
- 15 (1) 48 HOURS OF INPATIENT HOSPITALIZATION CARE AFTER A
- 16 MASTECTOMY; AND
- 17 (2) 24 HOURS OF INPATIENT HOSPITALIZATION CARE AFTER A LYMPH
- 18 NODE DISSECTION FOR THE TREATMENT OF BREAST CANCER.
- 19 (D) THIS SECTION MAY NOT BE CONSTRUED TO REQUIRE THE PROVISION OF
- 20 INPATIENT HOSPITALIZATION SERVICES IN ACCORDANCE WITH SUBSECTION (C) OF
- 21 THIS SECTION WHENEVER THE PATIENT DECIDES, IN CONSULTATION WITH THE
- 22 PATIENT'S ATTENDING PHYSICIAN, THAT A SHORTER PERIOD OF INPATIENT
- 23 HOSPITALIZATION IS APPROPRIATE FOR RECOVERY OR THAT THE MASTECTOMY
- 24 OR LYMPH NODE DISSECTION CAN BE PERFORMED ON AN OUTPATIENT BASIS.
- 25 (E) FOR A PATIENT WHO HAS A SHORTER HOSPITAL STAY THAN THAT
- 26 PROVIDED UNDER SUBSECTION (C) OF THIS SECTION OR DECIDES THAT THE
- 27 MASTECTOMY OR LYMPH NODE DISSECTION CAN BE PERFORMED ON AN
- 28 OUTPATIENT BASIS, AN ENTITY SUBJECT TO THIS SECTION SHALL PROVIDE
- 29 COVERAGE FOR:
- 30 (1) ONE HOME VISIT SCHEDULED TO OCCUR WITHIN 24 HOURS AFTER
- 31 DISCHARGE FROM THE HOSPITAL OR OUTPATIENT HEALTH CARE FACILITY: AND
- 32 (2) AN ADDITIONAL HOME VISIT IF PRESCRIBED BY THE PATIENT'S
- 33 ATTENDING PHYSICIAN.
- 34 (F) EACH ENTITY SUBJECT TO THIS SECTION SHALL PROVIDE NOTICE
- 35 ANNUALLY TO ITS ENROLLEES AND INSUREDS ABOUT THE COVERAGE REQUIRED
- 36 BY THIS SECTION.

- 3 (N) THE PROVISIONS OF § 15-822 OF THE INSURANCE ARTICLE SHALL APPLY
- 4 TO HEALTH MAINTENANCE ORGANIZATIONS.
- 5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 6 October 1, 1997.
