BE IT ENACTED BY THE GENERAL ASSEMBLY OF 20 21 MARYLAND, That the Laws of Maryland read as follows: 22 **Article - Insurance** 23 15-508. 24 (A) THIS SECTION APPLIES TO:

(1) INSURERS AND NONPROFIT HEALTH SERVICE PLANS THAT PROVIDE

26 HOSPITAL, MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR GROUPS ON AN 27 EXPENSE-INCURRED BASIS UNDER HEALTH INSURANCE POLICIES THAT ARE ISSUED

28 OR DELIVERED IN THE STATE; AND

- 1 (2) HEALTH MAINTENANCE ORGANIZATIONS THAT PROVIDE HOSPITAL,
- 2 MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR GROUPS UNDER
- 3 CONTRACTS THAT ARE ISSUED OR DELIVERED IN THE STATE.
- 4 (B) WHENEVER A TREATMENT GUIDELINE OR PROTOCOL THAT IS NOT A
- 5 GENERALLY ACCEPTED NATIONAL STANDARD OF CARE IS THE SOLE BASIS FOR
- 6 REDUCING THE LENGTH OF INPATIENT HOSPITALIZATION STAY FOR A PARTICULAR
- 7 MEDICAL OR SURGICAL PROCEDURE, AN ENTITY SUBJECT TO THIS SECTION MAY
- 8 NOT DENY INPATIENT HOSPITALIZATION COVERAGE FOR A LONGER LENGTH OF
- 9 STAY THAN THAT TO WHICH AN ENROLLEE OR INSURED IS OTHERWISE ENTITLED
- 10 UNDER THE CONTRACT OR POLICY IF THE INSURED'S OR ENROLLEE'S ATTENDING
- 11 PHYSICIAN HAS DETERMINED THAT A LONGER LENGTH OF INPATIENT
- 12 HOSPITALIZATION STAY IS MEDICALLY NECESSARY FOR RECOVERY.

- 15 (N) THE PROVISIONS OF § 15-508 OF THE INSURANCE ARTICLE SHALL APPLY 16 TO HEALTH MAINTENANCE ORGANIZATIONS.
- 17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 18 October 1, 1997.
