CHAPTER \_\_\_\_

1 AN ACT concerning

2 **Wildland and Open Areas - Designation of New Wildlands**

3 FOR the purpose of expanding the State wildland program by designating certain  
4 additional areas of the State as State Wildland; and generally relating to wildland  
5 areas in the State.

6 BY repealing and reenacting, without amendments,  
7 Article - Natural Resources  
8 Section 5-1203(a)  
9 Annotated Code of Maryland  
10 (1989 Replacement Volume and 1996 Supplement)

11 BY repealing and reenacting, with amendments,  
12 Article - Natural Resources

15 (1989 Replacement Volume and 1996 Supplement)

16 BY adding to

18 Section 5-1203(cc) through (ee)

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
22 MARYLAND, That the Laws of Maryland read as follows:

1 **Article - Natural Resources**

2 5-1203.

3 (a) In order to assure that an increasing population, accompanied by expanding  
4 settlement and growing mechanization, does not occupy and modify all areas within the  
5 State, leaving no lands designated for preservation and protection in their natural  
6 condition, it is the policy of the General Assembly to secure for the people of present and  
7 future generations the benefits of an enduring resource of State wildlands. For this  
8 purpose there is established a State wildlands preservation system composed of areas in  
9 the State designated by the General Assembly as "wildland areas". The wildland areas  
10 shall be administered for the use and enjoyment of the people of Maryland in a manner  
11 that will leave them unimpaired for the future use and enjoyment as wildlands, to provide  
12 for their protection, preservation of their wildland character, and for gathering and  
13 dissemination of information regarding their use and enjoyment as wildlands. A State  
14 land may not be designated as "wildland areas" except as provided for in this section or by  
15 a subsequent act.

16 (h) [(1)] Pursuant to the provisions of subsection (a) of this section, that property  
17 in Howard and Montgomery Counties containing approximately [824] 1579 acres and  
18 described as follows is a Type 2 State wildland and shall be named the "Patuxent River  
19 Wildland":

20 PARCEL 1:

21 Beginning at a point on the south shore of the Patuxent River at the eastern margin  
22 of the right-of-way of the Hipsley Mill Road, and proceeding counterclockwise about the  
23 boundary of the wildland area, southwesterly with said right-of-way margin  
24 approximately 3,050 feet to the southern boundary of Patuxent River State Park  
25 (hereafter the Park). Thence leaving Hipsley Mill Road and following said Park boundary  
26 southeasterly approximately 1,700 feet; thence leaving the Park boundary and with the  
27 forest bounding a field, on the right hand, easterly approximately 1,400 feet. Still with the  
28 forest edge southwesterly approximately 300 feet, thence easterly approximately 300 feet,  
29 thence southeasterly approximately 800 feet, thence southwesterly approximately 475  
30 feet, again to the Park boundary. Thence with said Park boundary southeasterly  
31 approximately 550 feet. Then leaving the Park boundary and again with the forest edge  
32 northeasterly approximately 1,150 feet, southeasterly approximately 400 feet, southerly  
33 approximately 275 feet, thence southeasterly approximately 750 feet, thence northeasterly  
34 approximately 550 feet, thence southeasterly approximately 250 feet, thence northeasterly  
35 approximately 500 feet. Thence still with the forest edge southeasterly approximately 600  
36 feet, thence southwesterly approximately 750 feet, thence easterly approximately 150 feet  
37 thence southerly approximately 250 feet, thence easterly approximately 900 feet. Thence  
38 again with the forest edge northeasterly approximately 1,100 feet, thence easterly  
39 approximately 300 feet, thence northeasterly approximately 1,400 feet, thence  
40 southeasterly approximately 650 feet, thence northerly approximately 1,050 feet, thence  
41 northeasterly approximately 550 feet, thence northerly approximately 420 feet to the  
42 Patuxent River. Thence crossing the river in a northwesterly direction approximately 100  
43 feet. Thence with the forest edge and the river southeasterly approximately 300 feet; then  
44 leaving the river and following the forest edge northeasterly with a field on the right,  
45 approximately 150 feet thence northerly approximately 420 feet, thence northwesterly

1 approximately 475 feet, thence northerly approximately 400 feet. Thence still with the  
 2 forest edge easterly approximately 150 feet, thence northerly approximately 650 feet,  
 3 thence westerly approximately 900 feet, thence northerly approximately 800 feet. Thence  
 4 leaving the forest edge and cutting through a narrow neck of woods, still northerly  
 5 approximately 200 feet, then again with the forest edge westerly approximately 550 feet.  
 6 Again cutting through a neck of woods still westerly approximately 550 feet. Once again  
 7 with the forest edge southwesterly approximately 450 feet, thence northwesterly  
 8 approximately 1,175 feet, thence southerly approximately 500 feet, thence westerly with  
 9 the forest edge approximately 300 feet, thence northeasterly approximately 1,375 feet,  
 10 thence northwesterly approximately 375 feet, thence southwesterly approximately 650  
 11 feet, thence northeasterly approximately 450 feet, thence still with the forest edge easterly  
 12 approximately 1,150 feet to the Park boundary. Thence with said Park boundary  
 13 northeasterly approximately 825 feet, thence northwesterly approximately 700 feet,  
 14 thence southwesterly approximately 800 feet, thence westerly approximately 350 feet,  
 15 thence northwesterly approximately 275 feet to an old field. Thence with the field on the  
 16 right hand and with the forest edge southwesterly approximately 375 feet, thence  
 17 northwesterly approximately 425 feet to Hipsley Mill Road. Thence with Hipsley Mill  
 18 Road southwesterly approximately 600 feet to the edge of an old field. Thence leaving  
 19 Hipsley Mill Road and with the field on the right hand and with the forest edge  
 20 southeasterly approximately 350 feet, thence southwesterly through a narrow neck of  
 21 woods approximately 525 feet, thence still with the forest edge southeasterly  
 22 approximately 1,150 feet, thence westerly approximately 300 feet, thence southeasterly  
 23 approximately 500 feet thence southerly approximately 400 feet, thence easterly  
 24 approximately 175 feet, thence with the field on the right hand and with the forest edge  
 25 southerly approximately 550 feet, thence westerly approximately 200 feet, thence  
 26 southwesterly approximately 475 feet, thence northwesterly approximately 250 feet,  
 27 thence northerly approximately 500 feet. Thence still with the forest edge northerly  
 28 approximately 350 feet, thence southerly approximately 550 feet, thence northwesterly  
 29 approximately 1,600 feet to the Hipsley Mill Road. Thence with the eastern margin of  
 30 said road right-of-way, southwesterly approximately 1,250 feet, thence southerly  
 31 approximately 750 feet again crossing the Patuxent River to the beginning point.

32 [(2)] A twenty-five hundredths (0.25) of an acre parking area located  
 33 approximately 50 feet northeast of the Patuxent River along the east side of Hipsley Mill  
 34 Road shall be excluded from the Patuxent River Wildland.

39            (k) Under the provisions of subsection (a) of this section, that property in Prince

3 SAVING AND EXEMPTING THE FOLLOWING DAY USE AREA DESCRIBED AS  
4 FOLLOWS:

17 MORE OR LESS TO A POINT ON THE EASTERNMOST SIDE OF BUNKER HILL ROAD,  
18 THENCE RUNNING WITH THE EASTERNMOST SIDE OF BUNKER HILL ROAD IN A  
19 SOUTHERLY DIRECTION 600.00 FEET MORE OR LESS TO A POINT, THENCE CROSSING  
20 BUNKER HILL ROAD AND RUNNING WITH THE WESTERNMOST EDGE OF AN OLD  
21 ROAD 900.00 FEET MORE OR LESS TO A POINT, SAID POINT BEING SITUATED SOUTH

25 SAVING AND EXEMPTING ALL PORTIONS OF BUNKER HILL ROAD.

26 SAVING AND EXEMPTING A PARKING AREA LOCATED NORTHEAST OF FALLS  
27 ROAD WITH MARYLAND GRID COORDINATES N648900 E886400, WITH A RADIUS OF 200  
28 FEET MORE OR LESS, AND THE EXISTING 36 FOOT WIDE ACCESS ROAD FROM FALLS  
29 ROAD, SAID ROAD BEING 900 FEET IN LENGTH.

30 SAVING AND EXEMPTING THE BALTIMORE GAS AND ELECTRIC POWER LINE  
31 RIGHT OF WAY LOCATED IN THE NORTHWEST PORTION OF THE ABOVE DESCRIBED  
32 WILDLAND.

33 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
34 October 1, 1997.
