1 AN ACT concerning

2 Workforce Reduction Act - Retirement Allowance for Deferred Retirements

3 FOR the purpose of providing that certain members of the Employees' Pension System

- 4 whose retirement under the Workforce Reduction Act was deferred shall receive
- 5 the greater of two retirement allowances computed as of certain dates; providing for
- 6 the construction of this Act; and generally relating to the computation of retirement
- 7 allowances of certain retirees under the Workforce Reduction Act.

8 BY repealing and reenacting, with amendments,

- 9 Chapter 353 of the Acts of the General Assembly of 1996
- 10 Section 2(9)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 12 MARYLAND, That the Laws of Maryland read as follows:
- 13 Chapter 353 of the Acts of 1996
- 14 SECTION 2. AND BE IT FURTHER ENACTED, That:

15 (9) (i) Except as provided in [subparagraph (ii)] SUBPARAGRAPHS (II)

16 AND (III) of this paragraph, a member of the Employees' Pension System who retires

17 under this section of this Act shall receive a service retirement allowance equal to the sum

18 of the member's creditable service and the additional credit described in paragraph (7) of

- 19 this section of this Act, multiplied by:
- 201. 0.8 percent of the member's average final compensation that21 is not in excess of the social security integration level; and
- 222. 1.5 percent of the member's average final compensation that23 exceeds the social security integration level; and

(ii) If a member has less than 30 years of creditable service and is less 1 2 than 62 years old, the member's retirement allowance computed under subparagraph (i) 3 of this paragraph shall be: 4 1. Reduced by the lesser of 0.5% for each month by which the 5 member's date of retirement precedes the date the member would be 62 years old or 6 42%; and 7 2. Increased by the lesser of 18% or the amount of the 8 reduction under sub-subparagraph 1 of this subparagraph; 9 (III) IF A MEMBER'S RETIREMENT IS DEFERRED UNDER SECTION 8 10 OR 9 OF THIS ACT, THE MEMBER SHALL RECEIVE THE GREATER OF A SERVICE 11 RETIREMENT ALLOWANCE COMPUTED UNDER SUBPARAGRAPHS (I) AND (II) OF THIS 12 PARAGRAPH AS OF THE RETIREMENT DATE OR A SERVICE RETIREMENT 13 ALLOWANCE THAT IS EQUAL TO THE SUM OF THE MEMBER'S CREDITABLE SERVICE 14 AS OF OCTOBER 1, 1996 AND THE ADDITIONAL CREDIT DESCRIBED IN PARAGRAPH 15 (7) OF THIS SECTION OF THIS ACT AS OF OCTOBER 1, 1996: 16 1. MULTIPLIED BY 0.8 PERCENT OF THE MEMBER'S 17 AVERAGE FINAL COMPENSATION THAT IS NOT IN EXCESS OF THE SOCIAL SECURITY 18 INTEGRATION LEVEL THAT IS IN EFFECT ON OCTOBER 1, 1996; 19 2. MULTIPLIED BY 1.5 PERCENT OF THE MEMBER'S 20 AVERAGE FINAL COMPENSATION THAT EXCEEDS THE SOCIAL SECURITY 21 INTEGRATION LEVEL THAT IS IN EFFECT ON OCTOBER 1, 1996; AND 3. IF, AS OF OCTOBER 1, 1996, THE MEMBER HAS LESS THAN 22 23 30 YEARS OF CREDITABLE SERVICE AND IS LESS THAN 62 YEARS OLD, THE MEMBER'S 24 RETIREMENT ALLOWANCE COMPUTED UNDER ITEMS 1 AND 2 OF THIS 25 SUBPARAGRAPH SHALL BE: A. REDUCED BY THE LESSER OF 0.5% FOR EACH MONTH BY 26 27 WHICH OCTOBER 1, 1996 PRECEDES THE DATE THE MEMBER WOULD BE 62 YEARS 28 OLD OR 42%; AND 29 B. INCREASED BY THE LESSER OF 18% OR THE AMOUNT OF 30 THE REDUCTION UNDER ITEM A OF THIS ITEM; 31 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed 32 retroactively and shall be applied to and interpreted to affect the computation of a 33 retirement allowance for any member of the Employees' Pension System whose 34 retirement was deferred under Chapter 353, § 8 or § 9, of the Acts of 1996.

35 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 36 June 1, 1997.
