## CHAPTER \_\_\_\_

1 AN ACT concerning

2 **Health Occupations - Alcohol and Drug Counselors - Certification**

3 FOR the purpose of altering the composition of the State Board of Examiners of  
4 Professional Counselors; altering certain qualifications for certification as a  
5 certified associate counselor-alcohol and drug; altering certain qualifications for the  
6 waiver of certain requirements for certification as a certified professional  
7 counselor-alcohol and drug, certified associate counselor-alcohol and drug, and  
8 certified supervised counselor-alcohol and drug; correcting certain erroneous titles;  
9 providing for the effective date of this Act; and generally relating to the  
10 qualifications for certification as an alcohol and drug counselor.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

20 MARYLAND, That the Laws of Maryland read as follows:

1 **Article - Health Occupations**

2 17-202.

3 (a) (1) The Board consists of [nine] 10 members appointed by the Governor  
4 with the advice of the Secretary.

5 (2) Of the [nine] 10 Board members:

6 (i) Five shall be certified as professional counselors, including:

7 1. One who is primarily engaged in professional counselor  
8 education;

9 2. One who is employed in the private sector;

10 3. One who is employed in the public sector; and

11 4. Two professional counselors at large;

12 (ii) One shall be a certified professional counsel-marriage and family  
13 therapist;

14 (iii) One shall be a certified professional counselor-alcohol and drug;  
15 [and]

16 (iv) Two shall be consumer members; AND

17 (V) ONE SHALL BE AN EX OFFICIO MEMBER WHO IS A CERTIFIED  
18 ASSOCIATE COUNSELOR-ALCOHOL AND DRUG OR A CERTIFIED SUPERVISED  
19 COUNSELOR-ALCOHOL AND DRUG.

20 (e) THE CERTIFIED ASSOCIATE COUNSELOR-ALCOHOL AND DRUG OR  
21 CERTIFIED SUPERVISED COUNSELOR-ALCOHOL AND DRUG MEMBER SHALL  
22 PARTICIPATE AS A MEMBER OF THE BOARD BUT SERVES IN AN EX OFFICIO  
23 CAPACITY WITHOUT VOTING PRIVILEGES.

24 (F) Before taking office, each appointee to the Board shall take the oath required  
25 by Article I, § 9 of the State Constitution.

26 [f] (G) (1) The term of a member is 4 years.

27 (2) The terms of the members of the Board are staggered as required by the  
28 terms of the members of the Board serving on July 1, 1988.

29 (3) At the end of a term, a member continues to serve until a successor is  
30 appointed and qualifies.

31 (4) A member may not serve more than 2 consecutive full terms.

32 (5) To the extent practicable, the Governor shall fill any vacancy on the  
33 Board within 60 days of the date of the vacancy.

34 [g] (H) (1) The Governor may remove a member for incompetency,  
35 misconduct, or neglect of duty.

1                   (2) Upon the recommendation of the Secretary, the Governor may remove a  
2 member whom the Secretary finds to have been absent from 2 successive Board meetings  
3 without adequate reason.

5                   To qualify as a certified associate counselor-alcohol and drug an applicant shall:

6                   (1) Hold a bachelor's degree from an accredited educational institution  
7 approved by the Board in a health or human services counseling field or have completed  
8 a program of studies judged by the Board to be substantially equivalent in subject matter  
9 and extent of training to such a program of studies;

10                  (2) Have completed not less than 3 years, with a minimum of 2,000 hours of  
11 supervised experience in alcohol and drug counseling approved by the Board, 2 years of  
12 which shall have been completed after the award of the bachelor's degree;

13                  (3) Have a minimum of 20 credit hours in alcohol and drug counselor  
14 training as defined in § 17-302.3(d)(4) of this title; and

15                  (4) (I) Practice alcohol and drug counseling under the supervision of a  
16 certified professional counselor-alcohol and drug or another health care provider  
17 approved by the Board; OR

18                                (II) PROVIDE ALCOHOL AND DRUG COUNSELING AS AN EMPLOYEE  
19 OF AN AGENCY OR FACILITY THAT IS ACCREDITED BY THE JOINT COMMISSION ON  
20 ACCREDITATION OF HEALTH CARE ORGANIZATIONS OR THAT IS CERTIFIED UNDER  
21 TITLE 8, SUBTITLE 4 OF THE HEALTH - GENERAL ARTICLE.

23                  (c) (1) The Board shall waive the requirements for certification as a certified  
24 professional counselor-alcohol and drug under § 17-302.3 of this subtitle for any person  
25 who:

26                               (i) Has filed a letter of intent with the Board by July 1, [ 1997] 1998;

27                               (ii) Holds a master's or doctoral degree in a health and human services  
28 counseling field or has completed a program that the Board determines to be  
29 substantially equivalent in subject matter and extent of training as a master's or doctoral  
30 degree in a health and human services counseling field;

31                               (iii) As of July 1, [1996] 1997, is certified as a certified chemical  
32 dependency counselor [or certified clinical supervisor] , ITS EQUIVALENT, OR HIGHER  
33 by the Maryland Addiction Counselor Certification Board, ANOTHER STATE, THE  
34 CERTIFICATION COMMISSION OF THE NATIONAL ASSOCIATION OF ALCOHOLISM  
35 AND DRUG ABUSE COUNSELORS, OR THE INTERNATIONAL CERTIFICATION  
36 RECIPROCITY CONSORTIUM, OR IS EMPLOYED IN THE CAPACITY OF A PROGRAM  
37 SPECIALIST I, II, III, OR ITS EQUIVALENT, OR HIGHER, IF THE PERSON IS EMPLOYED  
38 BY THE STATE, A POLITICAL SUBDIVISION OF THE STATE, OR AN ENTITY THAT  
39 PROVIDES ALCOHOL AND DRUG COUNSELING SERVICES UNDER CONTRACT WITH  
40 THE STATE OR A POLITICAL SUBDIVISION OF THE STATE; AND

 2 of supervised experience in alcohol and drug abuse counseling approved by the Board, 2  
 3 years of which shall have been completed after the award of the master's or doctoral

7 (2) The Board shall waive the requirements for certification as a certified  
 8 associate counselor-alcohol and drug for any person who has filed a letter of intent with  
 9 the Board by July 1, [1997] 1998 if:

10 (i) ~~{~~The person holds a bachelor's degree in a health or human  
 11 services counseling field or has completed a program that the Board determines to be  
 12 substantially equivalent in subject matter and extent of training to a bachelor's degree in  
 13 a health or human services counseling field;

14 (ii)~~}~~ The person, as of July 1, [1996] 1997, is certified as a certified  
 15 chemical dependency counselor [or certified clinical supervisor], ITS EQUIVALENT, OR  
 16 HIGHER, by the Maryland Addiction Counselor Certification Board, ANOTHER STATE,  
 17 THE CERTIFICATION COMMISSION OF THE NATIONAL ASSOCIATION OF  
 18 ALCOHOLISM AND DRUG ABUSE COUNSELORS, OR THE INTERNATIONAL

 20 Program Specialist I, II, [or] III, or its equivalent, OR HIGHER, if the person is employed

 25 minimum of 3,000 hours of supervised experience in alcohol and drug abuse counseling

 27 the bachelor's degree OR A PROGRAM THAT THE BOARD DETERMINES TO BE  
 28 SUBSTANTIALLY EQUIVALENT IN SUBJECT MATTER AND EXTENT OF TRAINING~~};~~

29 (3) The Board shall waive the requirements for certification as a certified  
 30 supervised counselor-alcohol and drug for any person who has filed a letter of intent with  
 31 the Board by July 1, [1997] 1998 if ~~{~~:

32 (i) The person holds an associate's degree in health or human services  
 33 counseling or has completed a program that the Board determines to be substantially  
 34 equivalent in subject matter and extent of training to an associate's degree in health or  
 35 human services counseling; or

36 (ii) The~~}~~ THE person, AS OF JULY 1, 1997, is certified as a certified  
 37 alcoholism counselor [or], certified drug counselor, OR HIGHER, by the Maryland  
 38 Addiction Counselor Certification Board, ANOTHER STATE, THE CERTIFICATION  
 39 COMMISSION OF THE NATIONAL ASSOCIATION OF ALCOHOLISM AND DRUG ABUSE  
 40 COUNSELORS, OR THE INTERNATIONAL CERTIFICATION RECIPROCITY  
 41 CONSORTIUM, or is employed in the capacity of an Addiction Counselor II or III, or its  
 42 equivalent, OR HIGHER, if the person is employed by the State, a political subdivision of

2 with the State or a political subdivision of the State.

4 SECTION 2. AND BE IT FURTHER ENACTED, That, notwithstanding whether  
5 the services are provided within the scope of practice of a certified professional  
6 [counselor-drug and alcohol therapist] COUNSELOR-ALCOHOL AND DRUG, a certified  
7 [counselor-drug and alcohol therapist] ASSOCIATE COUNSELOR-ALCOHOL AND  
8 DRUG, or a certified [associate counselor-drug and alcohol therapist] SUPERVISED  
9 COUNSELOR-ALCOHOL AND DRUG, nothing in this Act may be construed to require a  
10 nonprofit health service plan, insurer, health maintenance organization, or person acting  
11 as a third party administrator to reimburse a certified professional [counselor-drug and  
12 alcohol therapist] COUNSELOR-ALCOHOL AND DRUG, a certified [counselor-drug and  
13 alcohol therapist] SUPERVISED COUNSELOR-ALCOHOL AND DRUG, or a certified  
14 associate [counselor-drug and alcohol therapist] COUNSELOR-ALCOHOL AND DRUG.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
