1 AN ACT concerning

2 Insurance - Termination of Agency Agreements - Renewals of Policies

3 FOR the purpose of altering the amount of time during which certain insurers shall

- 4 continue to renew policies through an agent or broker with which the agency
- 5 agreement has terminated under certain circumstances; and generally relating to
- renewals of policies and termination of agency agreements in insurance. 6

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 19
- 20 MARYLAND, That the Laws of Maryland read as follows:

21 **Article - Insurance**

- 22 27-503.
- 23 (a) An insurer may not cancel a written agreement with an agent or broker about
- 24 insurance or refuse to accept insurance business from the agent or broker unless the

25 insurer complies with this section.

- 26 (b) (1) This subsection does not apply to:
- 27 (i) policies of life insurance, health insurance, surety insurance, wet

28 marine and transportation insurance, and title insurance; or

(ii) agents, brokers, or policies of a company or group of companies
represented by agents or brokers who by contractual agreement represent only that
company or group of companies if:

4 1. the business is owned by the company or group of companies; 5 and

6 2. the cancellation of any contractual agreement does not result 7 in the cancellation or refusal to renew any policies.

8 (2) If an insurer intends to cancel a written agreement with an agent or 9 broker or intends to refuse a class of renewal business from an agent or broker, the 10 insurer shall give the agent or broker at least 90 days written notice.

11 (3) Notwithstanding any provision of the agreement to the contrary, the

12 insurer shall continue for at least [1 year] 2 YEARS after termination of the agency

 $13\,$ agreement to renew through the agent or broker any of the policies that have not been

14 replaced with other insurers as expirations occur.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect16 October 1, 1997.
