CHAPTER ____

1 AN ACT concerning

2 **Anne Arundel County - State's Attorney - Salary Adjustments**

3 FOR the purpose of increasing the annual salary of the State's Attorney for Anne
4 Arundel County; providing that this Act does not apply to the salary or
5 compensation of the incumbent State's Attorney; and generally relating to the
6 salary of the State's Attorney for Anne Arundel County.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article 10 - Legal Officials**

16 (c) In Anne Arundel County:

17 (1) (i) The State's Attorney's annual salary is:

18 1. \$89,000 IN CALENDAR YEAR 1998;

19 2. ~~\$106,150~~ \$96,500 IN CALENDAR YEAR 1999; AND

20 3. IN CALENDAR YEAR 2000 AND EACH YEAR THEREAFTER,

21 AN AMOUNT THAT EQUALS THE PREVIOUS YEAR'S SALARY PLUS ~~2.5~~ 2.8 PERCENT OF

22 THAT SALARY.

1 (ii) The State's Attorney, during his term of office, may not appear,
2 except in connection with and in performance of his duties as State's Attorney, as counsel
3 or represent any party professionally before any court, board, commission or agency of
4 this State or any county or political subdivision of this State.

5 (iii) The State's Attorney may not engage in the private practice of law.

6 (2) The State's Attorney may appoint two deputy State's Attorneys and the
7 number of assistant State's Attorneys as provided by the County.

8 (3) The annual salary of the deputy State's Attorneys shall be within the
9 discretion of the State's Attorney, as approved by the County, but may not exceed 90
10 percent of the State's Attorney's salary.

11 (4) The annual salaries of the assistant State's Attorneys shall be within the
12 discretion of the State's Attorney, as approved by the County, but may not exceed 80
13 percent of the State's Attorney's salary.

14 (5) The deputy State's Attorneys and the assistant State's Attorneys shall be
15 precluded from the private practice of criminal law and, with the exception of one
16 assistant, shall serve full time.

17 (6) The State's Attorney may appoint clerical, administrative, investigative
18 and other assistants as in his judgment may be necessary for the proper conduct of his
19 office.

20 (7) The State's Attorney may from time to time, if considered necessary,
21 with the approval of the administrative judge of the Circuit Court for Anne Arundel
22 County, appoint a temporary assistant State's Attorney for a particular case or series of
23 cases and, with the concurrence of the County, may fix the compensation.

24 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III,
25 Section 35 of the Constitution of Maryland, this Act may not be construed to extend or
26 apply to the salary or compensation of the State's Attorney for Anne Arundel County in
27 office on the effective date of this Act, but the provisions of this Act concerning the salary
28 or compensation of the State's Attorney for Anne Arundel County shall take effect at the
29 beginning of the next following term of office.

30 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
31 October 1, 1997.
