- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 13 MARYLAND, That the Laws of Maryland read as follows:

14 Article 2B - Alcoholic Beverages

- 16 (A) THIS SECTION APPLIES ONLY IN THE UPPER CHARLES VILLAGE AREA OF 17 BALTIMORE CITY.
- 18 (B) (1) THE UPPER CHARLES VILLAGE AREA IS A CLOSED POLYGON WHICH 19 IS DEFINED AS FOLLOWS:
- 20 BEGINNING AT A POINT ON THE SOUTHEAST CORNER OF CHARLES STREET
- 21 AND 33RD STREET, THENCE SOUTH ALONG CHARLES STREET TO 29TH STREET;
- 22 THENCE WEST ON 29TH STREET TO HOWARD STREET; THENCE SOUTH ON HOWARD
- 23 STREET TO 26TH STREET; THENCE WEST BY SOUTHWEST ON 26TH STREET TO
- 24 HUNTINGDON AVENUE; THENCE SOUTHEAST ON HUNTINGDON AVENUE TO 25TH
- 25 STREET; THENCE EAST ON 25TH STREET TO HOWARD STREET; THENCE SOUTH ON
- 26 HOWARD STREET TO 24TH STREET; THENCE WEST ON 24TH STREET TO
- 27 HUNTINGDON AVENUE; THENCE SOUTH ON HUNTINGDON AVENUE TO 21ST STREET;
- 28 THENCE EAST ON 21ST STREET TO HOWARD STREET; THENCE SOUTH ON 21ST
- 29 STREET TO 20TH STREET; THENCE EAST ON 20TH STREET TO GUILFORD AVENUE;
- 30 THENCE NORTH ON GUILFORD AVENUE TO 25TH STREET; THENCE EAST ON 25TH
- 31 STREET TO LOCH RAVEN BOULEVARD; THENCE NORTHEAST ON LOCH RAVEN

- 1 BOULEVARD TO THE CSX RAILROAD TRACKS; THENCE WEST ON THE CSX RAILROAD
- 2 TRACKS TO GREENMOUNT AVENUE; THENCE NORTH ON GREENMOUNT AVENUE TO
- 3 OLD YORK ROAD; THENCE ALONG OLD YORK ROAD TO 35TH STREET; THENCE WEST
- 4 ON 35TH STREET TO GREENMOUNT AVENUE; THENCE SOUTH ON GREENMOUNT
- $5\,$ AVENUE TO 33RD STREET; THENCE WEST ON 33RD STREET TO THE POINT OF
- 6 BEGINNING.
- 7 (2) THE UPPER CHARLES VILLAGE AREA ONLY ENCOMPASSES THE
- 8 INSIDE OF THE POLYGON AND DOES NOT EXTEND TO THE FAR SIDE OF THE
- 9 STREETS AND TRACKS WHICH DEFINE IT.
- 10 (C) LICENSEES IN THE UPPER CHARLES VILLAGE AREA MAY NOT SELL:
- 11 (1) EXCEPT FOR BREWED BEVERAGES, ALCOHOLIC BEVERAGES THAT
- 12 ARE IN CONTAINERS THAT ARE A PINT OR LESS IN SIZE; AND
- 13 (2) FOR BREWED BEVERAGES, THOSE IN A SINGLE CONTAINER OF
- 14 WHATEVER SIZE.
- 15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 16 October 1, 1997.
