SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 18 19 MARYLAND, That the Laws of Maryland read as follows:

20 (C) TO ACCOMPLISH THE INTENT OF SUBSECTION (B) OF THIS SECTION, THE
21 OFFICE OF THE COMPTROLLER SHALL PROMULGATE REGULATIONS. THE
22 REGULATIONS MAY NOT BE EFFECTIVE UNTIL OCTOBER 1, 1998.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect24 October 1, 1997.
