- 2 Task Force to Review the Law Enforcement Officers' Bill of Rights and the Police
- 3 Training Commission Act
- 4 FOR the purpose of establishing a Task Force to Review the Law Enforcement Officers'
- 5 Bill of Rights and the Police Training Commission Act; providing for the
- 6 membership, chairman, duties, and staffing of the Task Force; requiring the Task
- 7 Force to issue a certain report; and generally relating to the establishment of a Task
- 8 Force to Review the Law Enforcement Officers' Bill of Rights and the Police
- 9 Training Commission Act.
- 10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 11 MARYLAND, That:
- 12 (a) There is a Task Force to Study the Law Enforcement Officers' Bill of Rights
- 13 and the Police Training Commission Act.
- 14 (b) The Task Force shall review the Law Enforcement Officers' Bill of Rights and
- 15 the Police Training Commission Act and propose a revision of both laws, unless it
- 16 concludes that a revision is not necessary.
- 17 (c) The Task Force shall assess the following issues in its review:
- 18 (1) The decisions of the Court of Appeals and the Court of Special Appeals
- 19 interpreting various sections of one or both laws;
- 20 (2) The legislative proposals that have been submitted to the Maryland
- 21 General Assembly to amend one or both laws;
- 22 (3) The views of law enforcement officers, law enforcement agencies, and
- 23 the public regarding the administration of disputes and the certification of law
- 24 enforcement officers in the State;
- 25 (4) The current law enforcement officer discipline and certification laws in
- 26 other states and legislative proposals regarding those laws, particularly in the
- 27 mid-Atlantic region of the United States; and
- 28 (5) Any other issues relating to the Law Enforcement Officers' Bill of
- 29 Rights and the Police Training Commission Act.
- 30 (d) The Task Force shall consist of 15 members as follows:

1 2	(1) The President of the Fraternal Order of Police, Maryland State Lodge, Inc., or the President's designee;
3	(2) The President of the Maryland Association of Chiefs of Police or the President's designee;
5 6	(3) The President of the Maryland Trooper's Association or the President's designee;
7	(4) The Secretary of the Department of State Police;
8 9	(5) The president of an employee organization representing county law enforcement officers, appointed by the Governor;
10 11	(6) The President of the Maryland Association of Counties or the President's designee;
12 13	(7) The president of an employee organization representing municipal law enforcement officers, appointed by the Governor;
14 15	(8) The President of the Maryland Municipal League or the President's designee;
16	(9) Two Senators, appointed by the President of the Senate;
17	(10) Two Delegates, appointed by the Speaker of the House of Delegates;
18	(11) Two members of the public, appointed by the Governor; and
19 20	(12) A chairman, who is not an employee of any governmental agency, appointed by the Governor.
21	(e) The members of the Task Force shall serve without compensation.
22	(f) The Task Force shall be staffed by the Department of Legislative Reference.
	(g) The Task Force shall issue a final report of its findings and recommendations, subject to $\S$ 2-1312 of the State Government Article, to the General Assembly on or before December 15, 1997.
26 27	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1997.
