25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 26 MARYLAND, That Section(s) 15-1301 through 15-1307, inclusive, and the subtitle
- 27 "Subtitle 13. Interdepartmental Committee on Mandated Health Insurance Benefits" of

2 SUBTITLE 13. ADVISORY PANEL ON MANDATED HEALTH INSURANCE BENEFITS.

4 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS 5 INDICATED.

6 (2) "ADVISORY PANEL" MEANS THE ADVISORY PANEL ON MANDATED7 HEALTH INSURANCE BENEFITS.

8 (3) (I) "MANDATED HEALTH INSURANCE BENEFIT" MEANS A
9 LEGISLATIVE PROPOSAL OR A STATUTE THAT WOULD REQUIRE A PARTICULAR
10 HEALTH CARE SERVICE, BENEFIT, COVERAGE, OR REIMBURSEMENT FOR COVERED
11 HEALTH CARE SERVICES TO BE PROVIDED OR OFFERED IN A HEALTH BENEFIT
12 PLAN BY A CARRIER OR OTHER ORGANIZATION AUTHORIZED TO PROVIDE HEALTH
13 BENEFIT PLANS IN THE STATE.

(II) "MANDATED HEALTH INSURANCE BENEFIT" INCLUDES A
LEGISLATIVE PROPOSAL OR A STATUTE THAT WOULD REQUIRE A HEALTH BENEFIT
PLAN THAT PROVIDES REIMBURSEMENT FOR A SERVICE TO PROVIDE
REIMBURSEMENT FOR THAT SERVICE WHEN PERFORMED BY ANY HEALTH CARE
PROVIDER WHO IS LICENSED UNDER THE HEALTH OCCUPATIONS ARTICLE AND
WHOSE SCOPE OF PRACTICE INCLUDES THAT SERVICE.

20 (III) "MANDATED HEALTH INSURANCE BENEFIT", AS APPLICABLE
21 TO ALL CARRIERS, DOES NOT INCLUDE SERVICES ENUMERATED TO DESCRIBE A
22 HEALTH MAINTENANCE ORGANIZATION UNDER § 19-701(F)(2) OF THE HEALTH 23 GENERAL ARTICLE.

24 (B) THIS SECTION DOES NOT AFFECT THE ABILITY OF THE GENERAL25 ASSEMBLY TO ENACT LEGISLATION ON MANDATED HEALTH INSURANCE BENEFITS.

26 (C) THERE IS AN ADVISORY PANEL ON MANDATED HEALTH INSURANCE27 BENEFITS.

(D) THE PURPOSE OF THE ADVISORY PANEL IS TO PROVIDE MEMBERS OF
THE MARYLAND GENERAL ASSEMBLY WITH AN ASSESSMENT OF THE CLINICAL AND
ECONOMIC IMPACT OF EACH MANDATED BENEFIT ON CONSUMERS, HEALTH CARE
PROVIDERS, AND THIRD PARTY PAYORS.

32 (E) (1) THE ADVISORY PANEL SHALL CONSIST OF:

33 (I) TWO PHYSICIANS FROM THE JOHNS HOPKINS SCHOOL OF34 MEDICINE, APPOINTED BY THE DEAN;

35 (II) ONE HEALTH ECONOMIST FROM THE JOHNS HOPKINS SCHOOL36 OF HYGIENE AND PUBLIC HEALTH, APPOINTED BY THE DEAN;

37 (III) TWO PHYSICIANS FROM THE UNIVERSITY OF MARYLAND38 SCHOOL OF MEDICINE, APPOINTED BY THE DEAN;

1 (IV) ONE REPRESENTATIVE OF THE MARYLAND HOSPITAL 2 ASSOCIATION: 3 (V) ONE REPRESENTATIVE OF THE MARYLAND ASSOCIATION OF **4 HEALTH MAINTENANCE ORGANIZATIONS;** (VI) ONE REPRESENTATIVE OF BLUE CROSS BLUE SHIELD OF 5 6 MARYLAND OR ITS SUCCESSOR ENTITY; (VII) ONE REPRESENTATIVE OF THE LEAGUE OF LIFE AND HEALTH 7 8 INSURERS: 9 (VIII) ONE REPRESENTATIVE OF THE HEALTH INSURANCE 10 ASSOCIATION OF AMERICA; 11 (IX) THE SECRETARY OF HEALTH AND MENTAL HYGIENE OR THE 12 SECRETARY'S DESIGNEE; AND 13 (X) THE MARYLAND INSURANCE COMMISSIONER OR THE 14 COMMISSIONER'S DESIGNEE. 15 (2) THE ADVISORY PANEL SHALL SELECT A CHAIRMAN FROM AMONG 16 ITS MEMBERS. 17 (3) THE ADVISORY PANEL SHALL MEET AT THE TIMES AND PLACES IT 18 DETERMINES. (F) THE ADVISORY PANEL SHALL UNDERTAKE AN ONGOING AND 19 20 SYSTEMATIC REVIEW OF ALL MANDATED HEALTH INSURANCE BENEFITS IN THIS 21 STATE FOR THE PURPOSE OF DETERMINING WHICH MANDATED HEALTH 22 INSURANCE BENEFITS DO NOT MEET CONSUMER NEEDS AND ARE NOT MEDICALLY 23 NECESSARY AND, THEREFORE, MAY BE REPEALED. (G) AS PART OF ITS REVIEW UNDER SUBSECTION (F) OF THIS SECTION, THE 24 25 ADVISORY PANEL SHALL: 26 (1) IF CONSIDERED APPROPRIATE BY THE ADVISORY PANEL, 27 EVALUATE RELEVANT MEDICAL LITERATURE; 28 (2) CONDUCT SURVEYS OF CONSUMERS, HEALTH CARE PROVIDERS, 29 AND THIRD PARTY PAYORS; (3) PERFORM ECONOMIC ANALYSES OF HEALTH CLAIMS DATA; AND 30 31 (4) CONSIDER: 32 (I) THE COST OF THE MANDATED HEALTH INSURANCE BENEFIT; 33 (II) THE EFFECTIVENESS OF THE MANDATED HEALTH INSURANCE 34 BENEFIT ON IMPROVING HEALTH STATUS; 35 (III) THE PERCENTAGE OF THE POPULATION UTILIZING THE 36 MANDATED HEALTH INSURANCE BENEFIT; AND

1 (IV) ANY OTHER INFORMATION THE ADVISORY PANEL CONSIDERS 2 APPROPRIATE.

3 (H) (1) THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE AND THE4 ADMINISTRATION SHALL PROVIDE STAFF SUPPORT TO THE ADVISORY PANEL.

5 (2) SUBJECT TO THE LIMITATIONS OF THE STATE BUDGET, THE
6 ADVISORY PANEL MAY CONTRACT FOR ACTUARIAL SERVICES AND OTHER
7 PROFESSIONAL SERVICES TO CARRY OUT THE PROVISIONS OF THIS SECTION.

8 (I) ON OR BEFORE DECEMBER 1, 1998, AND EACH DECEMBER 1 THEREAFTER,
9 SUBJECT TO § 2-1312 OF THE STATE GOVERNMENT ARTICLE, THE ADVISORY PANEL
10 SHALL SUBMIT A REPORT ON ITS FINDINGS, INCLUDING ANY RECOMMENDATIONS,
11 TO THE PRESIDENT OF THE SENATE OF MARYLAND, THE SPEAKER OF THE
12 MARYLAND HOUSE OF DELEGATES, AND THE RESPECTIVE CHAIRMEN OF THE
13 SENATE FINANCE COMMITTEE, THE HOUSE ECONOMIC MATTERS COMMITTEE, AND
14 THE HOUSE ENVIRONMENTAL MATTERS COMMITTEE.

15 SECTION 3. AND BE IT FURTHER ENACTED, That the Advisory Panel on

16 Mandated Health Insurance Benefits may make reasonable requests on carriers to submit

 $17\,$ data on the cost of a mandated health insurance benefit, utilization of a mandated health

18 insurance benefit, and any other information the Advisory Panel considers necessary to

19 carry out the provisions of this Act.

20 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect 21 October 1, 1997.
