- 22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 23 MARYLAND, That Section(s) 8-302 through 8-304.1 and 8-305 through 8-311,
- 24 respectively, of Article 2B Alcoholic Beverages of the Annotated Code of Maryland be
- 25 renumbered to be Section(s) 8-303 through 8-313, respectively.
- 26 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
- 27 read as follows:

Article 2B - Alcoholic Beverages

- 3 (A) THE BALTIMORE CITY BOARD OF LICENSE COMMISSIONERS MAY ISSUE A 4 SPECIAL BALTIMORE WINE FESTIVAL (BWF) LICENSE.
- 5 (B) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, AN APPLICANT FOR
- 6 A SPECIAL BWF LICENSE SHALL BE A HOLDER OF AN EXISTING STATE RETAIL
- 7 ALCOHOLIC BEVERAGES LICENSE, STATE CLASS 3 WINERY LICENSE, OR STATE
- 8 CLASS 4 WINERY LICENSE ISSUED UNDER THIS ARTICLE.
- 9 (C) A SPECIAL BWF LICENSE ENTITLES THE HOLDER TO DISPLAY AND SELL
- 10 AT RETAIL WINE FOR CONSUMPTION ON OR OFF THE LICENSE PREMISES ON THE
- 11 DAYS AND FOR THE HOURS DESIGNATED FOR THE BALTIMORE WINE FESTIVAL IN
- 12 BALTIMORE CITY.
- 13 (D) THE LICENSE FEE IS \$15.
- 14 (E) THE PROVISIONS OF THIS SECTION MAY NOT PROHIBIT THE LICENSEE
- 15 FROM HOLDING ANOTHER ALCOHOLIC BEVERAGES LICENSE OF A DIFFERENT
- 16 CLASS OR NATURE.
- 17 (F) THE BALTIMORE CITY BOARD OF LICENSE COMMISSIONERS:
- 18 (1) MAY SELECT ONE WEEKEND ANNUALLY FOR THE BALTIMORE WINE 19 FESTIVAL; AND
- 20 (2) SHALL CHOOSE A LOCATION IN BALTIMORE CITY FOR THIS
- 21 FESTIVAL WHICH DOES NOT HOLD AN ALCOHOLIC BEVERAGES LICENSE.
- 22 (G) THE BALTIMORE CITY BOARD OF LICENSE COMMISSIONERS SHALL
- 23 ADOPT REGULATIONS FOR IMPLEMENTING THIS SECTION.
