AMENDMENTS TO HOUSE BILL NO. 170

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, after “Crimes -” insert “Use of Cameras and”; in line 3, strike “or otherwise bringing,”; in line 4, strike “or otherwise bring,”; in the same line, strike “onto” and substitute “on”; in line 5, strike “visual surveillance” and substitute “deliberate surreptitious observation”; and in line 12, after “to” insert “use of cameras and”.

AMENDMENT NO. 2

On page 1, in line 23, strike “(1)”; strike beginning with the first “THE” in line 23 down through “(2)” in line 25, and substitute a comma; in line 26, strike “SURREPTITIOUSLY”; in the same line, after “OBSERVE” insert “SURREPTITIOUSLY”; and strike in their entirety lines 27 and 28.

AMENDMENT NO. 3

On page 2, in line 3, strike “OR BRINGS,”; in line 4, strike “OR BRING,”; in lines 5, 9, and 18 and 19, in each instance, strike “VISUAL SURVEILLANCE” and substitute “DELIBERATE SURREPTITIOUS OBSERVATION”; in line 8, strike “OR BRING”; in lines 4, 8, 17, and 31, in each instance, strike “ONTO” and substitute “ON”; and in lines 16 and 17, in each instance, strike “OR OTHERWISE BRING,”; in line 30, strike “OR OTHERWISE BROUGHT”; in lines 30 and 31, in each instance, strike the comma; and in line 31, strike “OR OTHERWISE BRING”.

AMENDMENT NO. 4

On page 2, in line 14, after “THE” insert “PRINT OR”.

On page 3, in line 29, after “THE” insert “PRINT OR”.

AMENDMENT NO. 5

On page 2, in line 13, strike “OR”; and in line 15, after “VIEW” insert “;

(Over)

(6) ANY PORTION OF A PRIVATE RESIDENCE USED FOR BUSINESS PURPOSES, INCLUDING ANY PORTION OF A DAY CARE HOME USED FOR THE CARE AND CUSTODY OF A CHILD; OR

(7) FILMING OF A PRIVATE RESIDENCE BY USING A CAMERA THAT IS NOT LOCATED ON THE REAL PROPERTY ON WHICH THE PRIVATE RESIDENCE IS LOCATED”.

AMENDMENT NO. 6

On page 3, in line 12, strike the second “OR”; and after line 12, insert:

“(VI) A SCHOOL OR OTHER EDUCATIONAL INSTITUTION;

(VII) A BANK OR OTHER FINANCIAL INSTITUTION;

(VIII) ANY PORTION OF A DAY CARE HOME USED FOR THE CARE AND CUSTODY OF A CHILD; OR”;

and in line 13, strike “(VI)” and substitute “(IX)”.

On page 4, in line 5, after “ARTICLE” insert “AND IS ACTING WITHIN THE SCOPE OF THE PERSON’S OCCUPATION”.
