AMENDMENT NO. 2

On page 3, in line 4, strike "employer" and substitute "<u>BUSINESS ENTITY</u>"; strike beginning with "40%" in line 14 down through "EMPLOYMENT" in line 16; in line 16, strike the bracket; in line 18, after the semicolon, insert "<u>AND</u>"; in line 20, strike "; and" and substitute a period; strike in their entirety lines 21 and 22; in line 26, after "18" insert "<u>OF THE LAST 48</u>"; in line 27, strike "THE EMPLOYER" and substitute "<u>A BUSINESS ENTITY</u>"; and in line 29, strike "50%" and substitute "40%";

On page 4, in line 22, strike the brackets; and in the same line, strike "40%".

On page 3, in lines 34, 35, and 37, in each instance, strike the bracket; in line 35, strike "UP"; in line 37, after the semicolon, insert "AND"; in line 39, strike the semicolon and substitute a period; and strike line 40 in its entirety.

AMENDMENT NO. 5

On pages 6 and 7, on page 6 in line 33 and on page 7 in lines 1, 9, and 15, in each instance, strike "2003" and substitute "2004".

On page 7, in line 32, after "1998" insert "and shall be applicable with respect to all employees hired after June 1, 1998".
