AMENDMENT NO. 1

In line 2, after "Administration -" insert "<u>Reporting of</u>"; in lines 2 and 3, strike "or Renewed - Reports"; in line 4, after "Administration" insert "<u>(MVA)</u>"; in line 6, strike "or renewed for licensed drivers" and substitute "<u>for vehicles registered</u>"; in line 7, after "State;" insert "<u>requiring the MVA to operate the reporting system and not contract with an outside entity for its operation; prohibiting the disclosure of certain insurance information; restricting mandatory reporting prior to a certain date;"; in the same line, strike "lapse of required security" and substitute "<u>reports to the Motor Vehicle Administration of insurance policies issued for vehicles registered in the State</u>"; and in line 10, strike "17-106(f)" and substitute "<u>17-106.1</u>".</u>

AMENDMENT NO. 2

In line 16, strike "17-106." and substitute "<u>17-106.1.</u>"; in line 17, strike "(F)" and substitute "<u>(A)</u>"; in the same line, strike "BEFORE JULY 1, 1999,"; in line 19, strike "17-203" and substitute "<u>17-103</u>"; in the same line, strike "ARTICLE" and substitute "<u>SUBTITLE</u>"; in line 20, strike "OR RENEWED FOR DRIVERS LICENSED" and substitute "<u>FOR VEHICLES REGISTERED</u>"; and after line 20, insert:

"(B) (1) THE ADMINISTRATION SHALL OPERATE THE REPORTING SYSTEM DEVELOPED UNDER SUBSECTION (A) OF THIS SECTION AND MAY NOT CONTRACT WITH AN OUTSIDE ENTITY FOR THE OPERATION OF THE SYSTEM.

(2) PARAGRAPH (1) OF THIS SUBSECTION MAY NOT BE CONSTRUED TO PROHIBIT THE ADMINISTRATION FROM CONTRACTING WITH AN OUTSIDE ENTITY FOR THE DESIGN OR DEVELOPMENT OF THE REPORTING SYSTEM AUTHORIZED UNDER SUBSECTION (A) OF THIS SECTION.
