AMENDMENTS TO SENATE BILL NO. 634

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and Van Hollen" and substitute "<u>Van Hollen</u>, <u>Bromwell, Astle, Hafer, Della, and Currie</u>".

AMENDMENT NO. 2

On page 1, in line 6, after the second "Program" insert "at certain levels for certain fiscal years"; and in line 7, after "regulations" insert ", to make a certain report to the General Assembly, and to work with certain organizations".

AMENDMENT NO. 3

On page 3, strike in their entirety lines 6 through 9, inclusive, and substitute:

"(E) (1) NOT LATER THAN JANUARY 1, 1999, THE DEPARTMENT SHALL REPORT TO THE GENERAL ASSEMBLY ON ITS PROGRESS ON, AND ITS PLANS FOR, IMPLEMENTATION OF THIS PROGRAM, INCLUDING FUNDING FOR SCREENING, DIAGNOSIS, AND TREATMENT.

- (2) TO ADMINISTER THE PROGRAM, THE DEPARTMENT SHALL ALLOCATE FROM ITS GENERAL FUND APPROPRIATION, AS WELL AS OTHER APPROPRIATE FUNDING SOURCES, AT LEAST:
 - (I) \$2,600,000 FOR FISCAL YEARS 1999, 2000, AND 2001; AND
 - (II) \$4,200,000 FOR EACH FISCAL YEAR BEGINNING WITH FISCAL

YEAR 2002.".

AMENDMENT NO. 4

On page 3, in line 10, after "SHALL" insert ": (1)";

and in line 11, after "PROGRAM" insert "; AND

(2) WORK WITH THE FOLLOWING ENTITIES TO CONTINUE TO ASSURE THAT BREAST CANCER SCREENING SERVICES ARE AVAILABLE TO WOMEN AT LEAST 40 YEARS OLD:

- (I) THE FEDERAL GOVERNMENT;
- (II) LOCAL HEALTH DEPARTMENTS IN THE STATE;
- (III) THE HEALTH SERVICES COST REVIEW COMMISSION;
- (IV) THE MARYLAND HEALTH CARE FOUNDATION;
- (V) THE MARYLAND HOSPITAL ASSOCIATION;
- (VI) THE MARYLAND ASSOCIATION OF HEALTH MAINTENANCE ORGANIZATIONS;
 - (VII) THE MEDICAL AND CHIRURGICAL FACULTY OF MARYLAND;
 - (VIII) THE MARYLAND RADIOLOGY ASSOCIATION;
 - (IX) THE MARYLAND AMBULATORY SURGERY ASSOCIATION;
 - (X) ARM IN ARM; AND
 - (XI) OTHER INTERESTED PARTIES".
