AMENDMENTS TO SENATE BILL NO. 634

(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 3, strike "requiring" and substitute "<u>authorizing</u>"; in lines 6 and 7, strike "requiring the Department to fund the Program <u>at certain levels for certain fiscal years</u>;"; and in lines 8 and 9, strike "<u>to make a certain report to the General Assembly, and to work with certain organizations</u>" and substitute "<u>and to work with certain interested parties to assure that breast cancer screening services are available to certain individuals</u>".

AMENDMENT NO. 2

On pages 1 and 2, strike in their entirety the lines beginning with line 16 on page 1 through line 15 on page 2, inclusive.

AMENDMENT NO. 3

On page 2, after line 21, insert:

"(2) "BIENNIAL" MEANS ONCE EVERY OTHER YEAR.";

in lines 22, 25, 28, and 33, strike "(2)", "(3)", "(4)", and "(5)", respectively, and substitute "(3)", "(4)", "(5)", and "(6)", respectively.

On page 3, in line 1, strike "ANNUAL" and substitute "<u>BIENNIAL</u>"; in line 7, strike "ANNUAL" and substitute "<u>BIENNIAL</u>".

AMENDMENT NO. 4

On page 2, in line 34, after "(1)" insert "SUBJECT TO THE LIMITATIONS OF THE STATE BUDGET,".

AMENDMENT NO. 5

On page 3, in line 1, after "TO" insert ": (I)"; in line 3, after "OVER" insert "; AND

(II) PROVIDE TREATMENT FOR INDIVIDUALS WHO ARE

IDENTIFIED BY THIS PROGRAM AS BEING IN NEED"; in line 2, strike "MAMMOGRAM" and substitute "MAMMOGRAMS"; and in the same line, strike "EXAMINATION" and substitute "EXAMINATIONS".

AMENDMENT NO. 6

On page 3, in line 10, strike "AT OR BELOW" and substitute "THAT DOES NOT EXCEED".

AMENDMENT NO. 7

On pages 3 and 4, strike in their entirety the lines beginning with line 19 on page 3 through line 21 on page 4, inclusive, and substitute:

"(E) THE DEPARTMENT SHALL:

(1) ADOPT REGULATIONS NECESSARY TO IMPLEMENT THE PROGRAM; AND

(2) WORK WITH ALL INTERESTED PARTIES TO ASSURE THAT BREAST CANCER SCREENING SERVICES ARE AVAILABLE TO WOMEN AT LEAST 40 YEARS OLD.

SECTION 2. AND BE IT FURTHER ENACTED, That the Department of Health and Mental Hygiene shall report to the General Assembly, in accordance with § 2-1246 of the State Government Article, on its progress and its plans for implementation, including funding for screening, diagnosis, and treatment of the Breast Cancer Screening Program established under § 20-116 of the Health - General Article.".
