At the top of page 1, strike "EMERGENCY BILL"; in line 8, strike "approval" and substitute "review and comment"; strike beginning with "select" in line 8 down through "institutions" in line 10 and substitute "provide certain information"; strike beginning with "the" in line 11 through the first "approval" in line 12 and substitute "certain information"; in line 12, strike "for funding approval"; in lines 12 and 13, strike "making this Act an emergency measure;"; and in line 17, strike "5-505" and substitute "5-506".

### AMENDMENT NO. 2

On page 2, in line 4, strike "2000" and substitute "2001"; in line 5 after "FUNDING" insert "UNDER THIS SUBTITLE".

On page 3, in line 3, after "INSTITUTION" insert "FOR FUNDING IN THE FISCAL YEAR FOLLOWING THE UPCOMING FISCAL YEAR"; in line 19, strike "SELECT INSTITUTIONS FOR APPROVAL FROM" and substitute "REVIEW AND COMMENT ON THE INSTITUTIONS ON"; in line 20 after "INSTITUTIONS" insert "AND THE EXTENT AND MANNER IN WHICH EACH WOULD FORWARD THE GOALS OF THE MARYLAND SCHOOLS FOR SUCCESS PROGRAM AND THE MARYLAND SCHOOL PERFORMANCE PROGRAM"; in line 21, strike "APPROVED" and substitute "QUALIFIED"; in the same line, after "INSTITUTIONS" insert "AND COMMENTS ON EACH INSTITUTION"; in line 22, strike "FINAL APPROVAL" and substitute "REVIEW AND COMMENT"; in line 25, after "SUBMIT" insert "TO THE GOVERNOR:

# (1) THE LIST OF QUALIFIED INSTITUTIONS;

(2) THE SUPERINTENDENT'S COMMENTS ON EACH INSTITUTION; AND

(3) THE BOARD'S COMMENTS, IF ANY, ON EACH INSTITUTION."; strike beginning with "THE LIST OF" in line 25 through "FUNDING." in line 27; and after line 27, insert:

"<u>5-506.</u>

THE DEPARTMENT SHALL ADOPT REGULATIONS TO IMPLEMENT THIS SUBTITLE.".

# AMENDMENT NO. 3

On page 3, strike in their entirety lines 28 through 32, inclusive, and substitute:

"SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 1998.".
