AMENDMENTS TO HOUSE BILL NO. 286

(Third Reading File Bill)

AMENDMENT NO. 1

On page 3, in line 22, strike "<u>AS A LAST RESORT</u>" and substitute "<u>WHEN NONTOXIC</u> OPTIONS ARE UNREASONABLE OR HAVE BEEN EXHAUSTED".

AMENDMENT NO. 2

On page 3, in line 37, after "SCHOOL" insert "SYSTEM".

On page 6, in line 23, strike "8" and substitute "8 1/2"; and in line 24, strike "11 1/2" and substitute "11".

AMENDMENT NO. 3

On page 5, in line 26, after "(1)" insert "EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS SUBSECTION,"; and in the same line, strike "48" and substitute "24".

On page 6, in line 6, strike "48" and substitute "24".

On page 7, in line 8, after "(2)" insert "EXCEPT AS PROVIDED IN PARAGRAPH (5) OF THIS SUBSECTION.".

AMENDMENT NO. 4

On page 5, in lines 35 and 36, strike ", AT THE REQUEST OF A PARENT, GUARDIAN, OR STAFF MEMBER,"; and in line 36, after "NOTIFICATION" insert ", REQUIRED UNDER PARAGRAPH (1) OF THIS SUBSECTION,".

AMENDMENT NO. 5

On page 6, strike in their entirety lines 12 through 14, inclusive, and substitute:

"(IV) THE FOLLOWING LANGUAGE:

"THE OFFICE OF PESTICIDE PROGRAMS OF THE UNITED STATES ENVIRONMENTAL PROTECTION AGENCY HAS STATED:

'WHERE POSSIBLE, PERSONS WHO POTENTIALLY ARE MORE SENSITIVE, SUCH AS PREGNANT WOMEN AND INFANTS (LESS THAN TWO YEARS OLD), SHOULD AVOID ANY UNNECESSARY PESTICIDE EXPOSURE.'"; AND";

and on the same page, strike lines 28 through 30, inclusive, and substitute:

"(IV) THE FOLLOWING LANGUAGE:

"THE OFFICE OF PESTICIDE PROGRAMS OF THE UNITED STATES ENVIRONMENTAL PROTECTION AGENCY HAS STATED:

'WHERE POSSIBLE, PERSONS WHO POTENTIALLY ARE MORE SENSITIVE, SUCH AS PREGNANT WOMEN AND INFANTS (LESS THAN TWO YEARS OLD), SHOULD AVOID ANY UNNECESSARY PESTICIDE EXPOSURE.'";".

On page 7, strike in their entirety lines 30 through 32, inclusive, and substitute:

"(IV) THE FOLLOWING LANGUAGE:

"THE OFFICE OF PESTICIDE PROGRAMS OF THE UNITED STATES ENVIRONMENTAL PROTECTION AGENCY HAS STATED:

<u>'WHERE POSSIBLE, PERSONS WHO POTENTIALLY ARE MORE SENSITIVE,</u>

<u>SUCH AS PREGNANT WOMEN AND INFANTS (LESS THAN TWO YEARS OLD), SHOULD</u>

<u>AVOID ANY UNNECESSARY PESTICIDE EXPOSURE.'"; AND</u>";

and in line 29, strike "PLANNED".
