# AMENDMENTS TO HOUSE BILL NO. 286

(First Reading File Bill)

## AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and Owings" and substitute ", Owings, Klausmeier, McHale, Ciliberti, Oaks, D. Davis, Billings, Nathan-Pulliam, Morhaim, and Frush".

### AMENDMENT NO. 2

On page 3, strike beginning with "THE" in line 4 down through the second "PESTS" in line 7 and substitute "A MANAGED PEST CONTROL PROGRAM IN WHICH METHODS ARE INTEGRATED AND USED TO KEEP PESTS FROM CAUSING ECONOMIC, HEALTH RELATED, OR AESTHETIC INJURY THROUGH THE UTILIZATION OF SITE OR PEST INSPECTIONS, PEST POPULATION MONITORING, EVALUATING THE NEED FOR CONTROL, AND THE USE OF ONE OR MORE PEST CONTROL METHODS INCLUDING SANITATION, STRUCTURAL REPAIR, NONCHEMICAL METHODS, AND, AS A LAST RESORT, PESTICIDES IN ORDER TO:

#### (I) MINIMIZE THE USE OF PESTICIDES; AND

# (II) MINIMIZE THE RISK TO HUMAN HEALTH AND THE ENVIRONMENT ASSOCIATED WITH PESTICIDE APPLICATIONS ";

and strike beginning with ", UNLESS" in line 11 down through "AIR" in line 12 and substitute "STATION".

# AMENDMENT NO. 3

On page 4, strike in their entirety lines 11 through 13 and substitute:

# "(I) A STATEMENT THAT EXPLAINS THE SCHOOL'S INTEGRATED PEST MANAGEMENT SYSTEM AND LISTS ANY PESTICIDE OR BAIT STATION THAT

**ENV** 

MAY BE USED IN A SCHOOL BUILDING AS PART OF THE INTEGRATED PEST MANAGEMENT SYSTEM;":

and in line 17, after "PESTICIDE" insert "OR BAIT STATION THAT MAY BE".

# AMENDMENT NO. 4

On page 5, in line 3, strike "24" and substitute "<u>48</u>"; in line 7, strike "AND"; and in line 8, after "APPLICATION" insert "; AND

(IV) UNITED STATES ENVIRONMENTAL PROTECTION AGENCY WARNING THAT PREGNANT WOMEN SHOULD REDUCE OR ELIMINATE EXPOSURE TO ALL PESTICIDES";

in line 9, after "MAY" insert "<u>, AT THE REQUEST OF A PARENT, GUARDIAN, OR STAFF MEMBER</u>,"; and after line 15, insert:

"(3) IN THE CASE OF A PESTICIDE APPLICATION IN AN ELEMENTARY SCHOOL, AT LEAST 48 HOURS BEFORE THE PESTICIDE IS APPLIED IN A SCHOOL BUILDING, THE SCHOOL SHALL PROVIDE TO EACH PARENT OR GUARDIAN, AND STAFF MEMBER:

- (I) THE COMMON NAME OF THE PESTICIDE;
- (II) THE LOCATION OF THE APPLICATION;
- (III) THE PLANNED DATE AND TIME OF APPLICATION;

(IV) THE UNITED STATES ENVIRONMENTAL PROTECTION AGENCY WARNING THAT PREGNANT WOMEN SHOULD REDUCE OR ELIMINATE EXPOSURE TO ALL PESTICIDES; AND

(V) A BRIEF DESCRIPTION OF POTENTIAL ADVERSE EFFECTS BASED UPON THE MATERIAL SAFETY SHEET OF THE PESTICIDES TO BE APPLIED.

(4) EACH SCHOOL SYSTEM SHALL DEVELOP AN APPROPRIATE MEANS OF IN-SCHOOL NOTIFICATION TO STUDENTS AND STAFF MEMBERS BEFORE A PESTICIDE IS APPLIED IN A MIDDLE SCHOOL OR HIGH SCHOOL.";

in line 20, strike "THE"; in line 21, after "(I)" insert "A"; in line 22, after "(II)" insert "A"; in the same line, strike "AND"; in line 23, after "(III)" insert "A"; in the same line strike the period and substitute a semicolon; and after line 23, insert:

"(IV) THE UNITED STATES ENVIRONMENTAL PROTECTION AGENCY WARNING THAT PREGNANT WOMEN SHOULD REDUCE OR ELIMINATE EXPOSURE TO ALL PESTICIDES;

(V) IF THE PESTICIDE IS NOT ADDRESSED IN THE NOTICE SENT AT THE BEGINNING OF THE SCHOOL YEAR, A BRIEF DESCRIPTION OF THE PESTICIDE TO BE APPLIED;

(VI) A BRIEF DESCRIPTION OF POTENTIAL ADVERSE EFFECTS

BASED UPON THE MATERIAL SAFETY DATA SHEET OF THE PESTICIDES TO BE

APPLIED; AND

(VII) THE NAME AND TELEPHONE NUMBER OF THE COUNTY DESIGNATED CONTACT PERSON.".

### AMENDMENT NO. 5

On page 6, after line 8, insert:

"(5) IN THE CASE OF AN EMERGENCY PESTICIDE APPLICATION IN AN ELEMENTARY SCHOOL, WITHIN 24 HOURS AFTER PESTICIDE APPLICATION, OR ON THE NEXT SCHOOL DAY, THE SCHOOL SHALL PROVIDE TO EACH PARENT, GUARDIAN, AND STAFF MEMBER:

### (I) THE COMMON NAME OF THE PESTICIDE;

(II) THE LOCATION OF THE APPLICATION;
(III) THE PLANNED DATE AND TIME OF APPLICATION;

(IV) THE UNITED STATES ENVIRONMENTAL PROTECTION AGENCY WARNING THAT PREGNANT WOMEN SHOULD REDUCE OR ELIMINATE EXPOSURE TO ALL PESTICIDES; AND

(V) A BRIEF DESCRIPTION OF POTENTIAL ADVERSE EFFECTS
BASED UPON THE MATERIAL SAFETY DATA SHEET OF THE PESTICIDES TO BE
APPLIED.";

and strike in their entirety lines 9 through 16 and substitute:

"(L) EACH SCHOOL SYSTEM SHALL DEVELOP APPROPRIATE MEANS OF INSCHOOL NOTIFICATION BEFORE A BAIT STATION IS USED IN THE SCHOOL. THE MEANS MAY INCLUDE A SIGN POSTED ON THE DOOR OF THE ROOM IN WHICH THE BAIT STATION IS PLACED.".
