AMENDMENTS TO HOUSE BILL NO. 766

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “and Watson” and substitute “Watson, Oaks, McHale, and Ciliberti”; in line 3, strike “requiring” and substitute “authorizing”; in line 6, strike “requiring the Department to fund the Program;”; and in line 7 after “regulations” insert “and to work with certain interested parties to assure that breast cancer screening services are available to certain individuals”.

AMENDMENT NO. 2

On pages 1 and 2, strike in their entirety the lines beginning with line 14 on page 1 through line 9 on page 2, inclusive.

AMENDMENT NO. 3

On page 2, after line 15, insert:

“(2) “BIENNIAL” MEANS ONCE EVERY OTHER YEAR.”; in lines 16, 19, 22, and 27, strike “(2)”, “(3)”, “(4)”, and “(5)”, respectively, and substitute “(3)”, “(4)”, “(5)”, and “(6)”, respectively; in line 36, strike “ANNUAL” and substitute “BIENNIAL”; in line 30, strike “AN ANNUAL” and substitute “BIENNIAL”; in line 31, strike “MAMMOGRAM” and substitute “MAMMOGRAMS”; and in the same line, strike “EXAMINATION” and substitute “EXAMINATIONS”.

AMENDMENT NO. 4

On page 2, in line 28, after “(1)” insert “SUBJECT TO THE LIMITATIONS OF THE STATE BUDGET,”; in line 30, after “TO” insert “: (I)”; and in line 32, after “OVER” insert “: AND”

(II) PROVIDE TREATMENT FOR INDIVIDUALS WHO ARE IDENTIFIED BY THIS PROGRAM AS BEING IN NEED”.

AMENDMENT NO. 5

On page 3, in line 2, strike “AT OR BELOW” and substitute “THAT DOES NOT EXCEED”; strike in their entirety lines 7 through 10, inclusive; in line 11, strike “(F)” and substitute “(E)”; in the same line, after “SHALL” insert “: (1)”; and in line 12, after “PROGRAM” insert “; AND”

(2) WORK WITH ALL INTERESTED PARTIES TO ASSURE THAT BREAST CANCER SCREENING SERVICES ARE AVAILABLE TO WOMEN AT LEAST 40 YEARS OLD”.

AMENDMENT NO. 6

On page 3, after line 12, insert:

“SECTION 2. AND BE IT FURTHER ENACTED, That the Department of Health and Mental Hygiene shall report to the General Assembly, in accordance with § 2-1246 of the State Government Article, on its progress and its plans for implementation, including funding for screening, diagnosis, and treatment of the Breast Cancer Screening Program established under § 20-116 of the Health - General Article.”; and in line 13, strike “2.” and substitute “3.”.
