AMENDMENTS TO SENATE BILL NO. 767

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 6, after "employees" insert ", subject to certain conditions."; strike beginning with "qualifications," in line 7 down through "employment," in line 8, and substitute "qualifications"; and in line 10, after "benefits;" insert "requiring that the Commission make a certain annual report to the Governor and the General Assembly; requiring that the Commission submit certain proposed salary changes to the Secretary of Budget and Management and that the Secretary review and provide advice with regard to the changes; requiring that the Governor's budget include certain information;".

AMENDMENT NO. 2

On page 2, in line 9, after "APPOINT" insert "UP TO A TOTAL OF 12 MANAGEMENT PERSONNEL"; in line 10, strike "ANY" and insert "ALL"; strike beginning with "QUALIFICATIONS," in line 13 down through "SUBSECTION." in line 15 and substitute "QUALIFICATIONS AND APPOINTMENT, AS WELL AS COMPENSATION AND LEAVE, FOR EMPLOYEES APPOINTED UNDER THIS SUBSECTION.

(III) AT LEAST 10 DAYS BEFORE THE EFFECTIVE DATE OF THE CHANGE, THE COMMISSION SHALL SUBMIT TO THE SECRETARY OF BUDGET AND MANAGEMENT EACH CHANGE TO THE SALARIES OF THESE EMPLOYEES THAT INVOLVES INCREASES IN SALARY RANGES OTHER THAN THOSE ASSOCIATED WITH GENERAL SALARY INCREASES APPROVED BY THE GENERAL ASSEMBLY.

(IV) THE SECRETARY OF BUDGET AND MANAGEMENT SHALL:

1. REVIEW THE PROPOSED CHANGES; AND

2. WITHIN 10 DAYS OF RECEIPT OF THE PROPOSED

(Over)

CHANGES, ADVISE THE COMMISSION WHETHER THE CHANGES WOULD HAVE AN ADVERSE EFFECT ON SPECIAL FUND EXPENDITURES.

(V) FAILURE OF THE SECRETARY OF BUDGET AND MANAGEMENT TO RESPOND IN A TIMELY MANNER IS DEEMED TO BE A STATEMENT THAT THE CHANGE WILL HAVE NO ADVERSE EFFECT.”;

and in line 16, strike “(III)” and substitute “(VI)”.

AMENDMENT NO. 3

On page 2, after line 19, insert:

“(VII) ON OR BEFORE DECEMBER 1 OF EACH YEAR, THE COMMISSION SHALL REPORT TO THE GOVERNOR AND THE LEGISLATIVE POLICY COMMITTEE OF THE GENERAL ASSEMBLY ON ACTIONS TAKEN BY THE COMMISSION UNDER THIS SUBSECTION DURING THE PREVIOUS FISCAL YEAR WITH REGARD TO INDIVIDUALS SUBJECT TO THIS SUBSECTION.

(3) THE BUDGET SUBMITTED BY THE GOVERNOR TO THE GENERAL ASSEMBLY SHALL INCLUDE PERSONNEL DETAIL FOR THE PRIVATE OPERATING COMPANIES IN THE FORM AND MANNER PROVIDED FOR AN AGENCY IN THE STATE PERSONNEL MANAGEMENT SYSTEM.”;

and in line 20, strike “(3)” and substitute “(4)”.
