# AMENDMENTS TO HOUSE BILL NO. 8

(First Reading File Bill)

## AMENDMENT NO. 1

On page 1, in line 15, strike "a certain term" and substitute "certain terms".

#### AMENDMENT NO. 2

On page 2, strike in their entirety lines 1 through 36, inclusive.

#### AMENDMENT NO. 3

On page 3, in line 4, strike "IN THIS SUBTITLE," and substitute:

"(A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

(B)";

and after line 5, insert:

"(C) "TREATMENT" MEANS TREATMENT THAT IS RECEIVED IN AN ALCOHOL ABUSE AND DRUG ABUSE TREATMENT PROGRAM, AS DEFINED IN § 8-403 OF THIS TITLE, THAT IS CERTIFIED BY THE ADMINISTRATION OR EXEMPT FROM THE CERTIFICATION REQUIREMENTS UNDER § 8-403 OF THIS TITLE.".

## AMENDMENT NO. 4

On page 4, in lines 14 and 15, strike "UNDER ITEM (1) OF THIS SUBSECTION" and substitute "FOR WHOM EMPLOYMENT IS AN APPROPRIATE GOAL AND WHO ARE EMPLOYED AT THE TIME OF DISCHARGE".

# AMENDMENT NO. 5

On page 4, in line 21, strike "1 YEAR" and substitute "2 YEARS".

## AMENDMENT NO. 6

On page 4, in line 38, after "PROPOSAL" insert ", INCLUDING FUNDS TO COVER THE LIVING EXPENSES THAT CLIENTS IN THE PROGRAM WOULD OTHERWISE OWE TO A FACILITY THAT IS CERTIFIED BY THE ADMINISTRATION OR EXEMPT FROM THE CERTIFICATION REQUIREMENTS UNDER § 8-403 OF THIS TITLE,".

# AMENDMENT NO. 7

On page 5, in line 5, strike "AND"; and in line 8, after "CONTINUATION" insert "; AND

(10) THE APPLICANT'S PLAN TO ENSURE THAT CLIENTS IN THE PROGRAM RECEIVE TREATMENT IN AN ALCOHOL ABUSE AND DRUG ABUSE TREATMENT PROGRAM, AS DEFINED IN § 8-403 OF THIS TITLE, THAT IS CERTIFIED BY THE ADMINISTRATION OR EXEMPT FROM THE CERTIFICATION REQUIREMENTS UNDER § 8-403 OF THIS TITLE";

and in line 12, strike "TO IMPLEMENT" and substitute "NOT INCONSISTENT WITH".
