AMENDMENT NO. 1

On page 3, strike in their entirety lines 2 through 14, inclusive; and in line 15, strike "(3)" and substitute "(2)".

AMENDMENT NO. 2

On page 4, strike beginning with "REPRESENTATIVE" in line 3 down through "INC." in line 4 and substitute "<u>MEMBER OF THE GENERAL PUBLIC WITH KNOWLEDGE OF PUBLIC</u> <u>HEALTH</u>"; and strike beginning with "REPRESENTATIVE" in line 5 down through "BUREAU" in line 6 and substitute "<u>MEMBER OF THE GENERAL PUBLIC WITH WORKING</u> <u>KNOWLEDGE OF AGRICULTURE</u>".

AMENDMENT NO. 3

On page 4, in line 24, before "PREPARE" insert "<u>SUBJECT TO SUBSECTION (F) (1) OF</u> <u>THIS SECTION, AND NOTWITHSTANDING ANY OTHER PROVISION OF LAW</u>,"; in line 27, strike "FUND, REFLECTING THOSE RECOMMENDATIONS" and substitute "<u>FUND FOR THE</u> <u>FOLLOWING PURPOSES</u>:

<u>1. REDUCTION OF THE USE OF TOBACCO PRODUCTS BY</u> PERSONS UNDER THE AGE OF 18 YEARS;

2. ALTERNATIVE CROP USES FOR AGRICULTURAL LAND NOW USED FOR GROWING TOBACCO;

3. PUBLIC EDUCATION CAMPAIGNS TO DECREASE

TOBACCO USE;

4. SMOKING CESSATION PROGRAMS;

(Over)

5. ENFORCEMENT OF THE LAWS REGARDING TOBACCO

SALES;

<u>6. THE PURPOSES OF THE MARYLAND HEALTH CARE</u> FOUNDATION UNDER TITLE 20, SUBTITLE 5 OF THE HEALTH - GENERAL ARTICLE; AND

<u>7. PREVENTION AND TREATMENT RESEARCH RELATING TO</u> TOBACCO PRODUCT USE AND TOBACCO CONTROL";

and after line 34, insert:

"(10) THOSE AVAILABLE FUNDS NOT ALLOCATED BY THE GOVERNOR FOR EXPENDITURE ON THE PURPOSES IN PARAGRAPH (7) (II) OF THIS SUBSECTION MAY BE SPENT ON ANY OTHER PURPOSES PERMITTED BY LAW.".
