On page 1, in line 3, after "Fingerprinting" insert "and Criminal History Records Checks"; strike beginning with "forward" in line 6 down through "check" in line 9 and substitute "follow certain procedures and satisfy certain requirements in obtaining a certain criminal history records check from the Criminal Justice Information System Central Repository of the Department of Public Safety and Correctional Services"; and in lines 14 and 15, strike "fingerprinting applicants for an alcoholic beverages license" and substitute "obtaining fingerprints and criminal history records checks from applicants for alcoholic beverages licenses".

AMENDMENT NO. 2

On page 2, in line 14, after "(3)" insert "<u>FOR EACH LICENSE APPLICANT</u>,"; strike in their entirety lines 15 through 24, inclusive, and substitute:

"(I) APPLY TO THE CRIMINAL JUSTICE INFORMATION SYSTEM CENTRAL REPOSITORY OF THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES FOR A STATE AND NATIONAL CRIMINAL HISTORY RECORDS CHECK; AND

(II) SUBMIT AS PART OF AN APPLICATION FOR A CRIMINAL HISTORY RECORDS CHECK:

On page 3, in lines 4 and 9, strike "(7)" and "(8)", respectively, and substitute "(8)" and "(9)", respectively; in line 2, after "MEMBERS," insert "<u>THE BOARD'S DESIGNEES</u>,"; in the same line, strike "THE BOARD'S ATTORNEY,"; and in line 4, strike "BEVERAGE" and substitute "<u>BEVERAGES</u>".
