## AMENDMENTS TO HOUSE BILL NO. 928

(First Reading File Bill)

## AMENDMENT NO. 1

On page 1, in the sponsor line, strike "Delegate Bissett" and substitute "Delegates Bissett and Arnick".

AMENDMENT NO. 2
On page 1, in lines 3 and 4, strike "a licensee" and substitute "an individual under a certain age who is convicted of certain alcohol related driving offenses"; strike beginning with "requiring" in line 7 down through "offenses;" in line 11; and strike beginning with "authorizing" in line 14 down through "Program;" in line 17.

## AMENDMENT NO. 3

On page 2 , in line 7 , strike "16-205,"; in line 8 , strike " $16-206$,"; and in line 13 , after "16-205.1(f)(8)(v)" insert ", 16-206,".

## AMENDMENT NO. 4

On page 2, in line 20, after "(a)" insert "(1)"; in lines 23, 26, and 32, strike "(1)", "(2)", and "(3)", respectively, and substitute "(I)", "(II)", and "(III)", respectively; strike beginning with the comma in line 27 down through "TITLE" in line 31; and after line 34, insert:
"(2) AN ALCOHOL RESTRICTION THAT PROHIBITS THE LICENSEE FROM DRIVING OR ATTEMPTING TO DRIVE A MOTOR VEHICLE WHILE HAVING ALCOHOL IN THE LICENSEE'S BLOOD MAY, AS DESCRIBED IN SUBSECTIONS (B) AND (G) OF THIS SECTION, INCLUDE A RESTRICTION THAT PROHIBITS THE LICENSEE FROM DRIVING OR ATTEMPTING TO DRIVE A MOTOR VEHICLE UNLESS THE LICENSEE IS A PARTICIPANT IN THE IGNITION INTERLOCK PROGRAM ESTABLISHED UNDER § 16-404.1 OF THIS TITLE.".

## Page 2 of 3

On page 3, strike beginning with ", OR" in line 11 down through "FOR," in line 12; in line 12 , strike "SHALL" and substitute "MAY"; in line 13, after "OF" insert "NOT MORE THAN"; and strike beginning with "OR" in line 13 down through "FIRST" in line 14.

On page 4 , in line 12, strike "(a)(2)" and substitute "(A)(1)(II)"; in line 12, strike the brackets; in line 13, strike "PROHIBITS AN INDIVIDUAL"; strike beginning with "AND" in line 14 down through "TITLE" in line 15; in line 16, after "convicted" insert "WITHIN 5 YEARS"; in line 16, strike the brackets; strike beginning with the colon in line 16 down through "ANY" in line 17 ; in lines 17 and 18 , strike "or (b)" and substitute ", (B), OR (C)"; strike beginning with the semicolon in line 18 down through "MORE" in line 26; and in line 29, after "ORDERS" insert " UNDER § 27-107 OF THIS ARTICLE,".

On page 4 , strike in their entirety lines 33 through 38 , inclusive.

On page 5, strike in their entirety lines 1 through 3, inclusive.

## AMENDMENT NO. 6

On pages 5 and 6, strike in their entirety the lines beginning with line 11 on page 5 through line 24 on page 6.

## AMENDMENT NO. 7

On page 10, in line 6, after "license" insert ", INCLUDING A RESTRICTION THAT PROHIBITS THE LICENSEE FROM DRIVING OR ATTEMPTING TO DRIVE A MOTOR VEHICLE UNLESS THE LICENSEE IS A PARTICIPANT IN THE IGNITION INTERLOCK SYSTEM PROGRAM ESTABLISHED UNDER § 16-404.1 OF THIS TITLE,"; and in line 23, after "TITLE" insert "FOR AT LEAST 180 DAYS AND NOT MORE THAN 1 YEAR".

## AMENDMENT NO. 8

On page 12 , strike in their entirety lines 24 through 28 , inclusive.

## AMENDMENT NO. 9

On page 13, in line 33, strike "PERSONS" and substitute "SERVICE PROVIDERS".

On page 14 , in lines $1,3,5,7$, and 8 , in each instance, strike "PERSON" and substitute

On page 14, in line 25, after "§ 16-113" insert "(B) OR (G)"; in line 25 , after the semicolon insert "OR"; strike beginning with "(IV)" in line 26 down through "OR" in line 27; in line 28, strike "(V)" and substitute "(IV)"; and in line 29, strike "§ 16-205.1(N)(4)" and substitute " $\$ 16-205.1(\mathrm{~N})(2)$ OR (4)".

On page 15, in line 15, strike the brackets; in line 16, strike "16-404(C)(2)(III)"; in line 16, strike the brackets; and in line 16, strike "(3)(III)".

## AMENDMENT NO. 11

On page 16, strike beginning with ", IN" in line 27 down through "PROVIDERS," in line 28.

On page 18, in line 9, after "ARTICLE;" insert "AND"; in line 12, strike the semicolon and substitute a period; and strike in their entirety lines 13 through 34 , inclusive.

On page 19, strike in their entirety lines 1 through 3, inclusive.
