AMENDMENT NO. 1

On page 1, strike beginning with "altering" in line 3 down through "exceptions;" in line 4; in line 7, after "purposes;" insert "<u>requiring the juvenile court to report certain juvenile record information to the Criminal Justice Information System Central Repository;</u>"; and in line 15, strike "3-804, 3-806, and".

AMENDMENT NO. 2

On pages 2 through 5, strike in their entirety the lines beginning with line 19 on page 2 through line 12 on page 5, inclusive.

AMENDMENT NO. 3

On page 5, in line 22, after "AGENCY" insert "<u>OF THE STATE OR OF A POLITICAL</u> <u>SUBDIVISION OF THE STATE</u>".

AMENDMENT NO. 4

On page 11, strike in its entirety line 1; in lines 2, 3, and 4, strike "(3)", "(4)", and "(5)", respectively, and substitute "(2)", "(3)", and "(4)", respectively; strike in its entirety line 5; in lines 6, 7, and 8, strike "(7)", "(8)", and "(9)", respectively, and substitute "(5)", "(6)", and "(7)", respectively; in lines 10 and 12, strike "(10)" and "(11)", respectively, and substitute "(8)" and "(9)", respectively; in lines 10 and 12, in each instance, strike "TWO" and substitute "<u>THREE</u>"; in line 14, strike "(12)" and substitute "(10)"; strike beginning with "IN" in line 16 down through "AREA" in line 17 and substitute "OF A POLITICAL SUBDIVISION OF THE STATE"; strike beginning with "IN" in line 18 down through "AREA" in line 19; in line 20, strike "<u>VICTIMS</u>" and substitute "<u>VICTIMS</u>"; strike beginning with "WITH" in line 22 down through "FIELD;" in line 23, and substitute "<u>WHO IS A RECOGNIZED CHILD ADVOCATE WITH EXPERIENCE IN JUVENILE JUSTICE; AND</u>"; in line 24, strike "PERSON FAMILIAR WITH"; in line 25, strike the semicolon and substitute "<u>EXPERT.</u>"; strike in their entirety lines 26 through 29, inclusive; in line 30, strike

"<u>A MEMBER</u>" and substitute "<u>THE MEMBERS</u>"; and strike beginning with "<u>AN</u>" in line 31 down through "<u>MEMBER'S</u>" in line 32 and substitute "<u>A MEMBER OF THEIR</u>".

On page 12, in line 1, in each instance, strike "<u>THE MEMBER</u>" and substitute "<u>THEM</u>"; and in line 2, strike "<u>THE MEMBER</u>" and substitute "<u>THEY</u>".
