CHAPTER _____

1 AN ACT concerning

2 **Higher Education - Professional School Scholarship Program - Social Work**

3 FOR the purpose of adding social work scholarship programs to a list of scholarship
4 programs provided by the State from the proceeds of certain fees paid into a
5 special fund administered by the Maryland Higher Education Commission for
6 use in the professional school scholarship programs; and increasing the amount
7 of money that shall be paid into the special fund administered by the Maryland
8 Higher Education Commission for use in the professional school scholarship
9 programs.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article - Transportation**

18 13-613.

19 (a) (1) The owner of any vehicle described in paragraph (2) of this subsection
20 may apply to the Administration for the assignment to that vehicle of a special,
21 personalized registration number.

- 1 (2) This section applies only as to:
- 2 (i) A Class A (passenger) vehicle;
- 3 (ii) A Class D (motorcycle) vehicle;
- 4 (iii) A Class E (truck) vehicle with a one ton or less manufacturer's
5 rated capacity;
- 6 (iv) A Class G (nonfreight trailer) vehicle;
- 7 (v) A Class L (historic) vehicle;
- 8 (vi) A Class M (multipurpose) vehicle; or
- 9 (vii) A Class N (street rod) vehicle.

10 (b) In addition to the annual registration fee otherwise required by this title,
11 the applicant shall pay an additional annual fee of \$25, payable with the original and
12 each renewal application for special registration under this section.

13 (c) (1) A special registration number assigned under this section may
14 consist of any combination of not more than 7 letters and numerals.

15 (2) In its discretion, the Administration may refuse any combination of
16 letters and numerals.

17 (d) Except as provided in subsection (e) of this section, of the proceeds
18 collected annually from the additional fees charged under this section:

19 (1) The first [\$150,000] \$180,000 shall be paid into a special fund
20 administered by the Maryland Higher Education Commission for use in the medical,
21 dental, legal, nursing, SOCIAL WORK, and pharmaceutical scholarship programs
22 provided by this State;

23 (2) The next \$200,000 shall be used solely for the purposes of the
24 scholarship program authorized by §§ 18-1101 through 18-1105 of the Education
25 Article of the Code; and

26 (3) Except as otherwise provided by law, any balance shall be paid
27 directly into the general funds of this State.

28 (e) (1) The Administration shall keep \$12.50 of the fee payable with the
29 original application for special registration under this section to recover the
30 administrative and production costs of the special registration.

31 (2) Funds kept by the Administration under this subsection may not be
32 credited to the Gasoline and Motor Vehicle Revenue Account for distribution under §
33 8-403 or § 8-404 of this article.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
2 July 1, 1998.
