14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

21 Section 35 of the Constitution of Maryland, this Act may not be construed to extend or

22 apply to the salary or compensation of the judges of the Orphans' Court for Howard

23 County in office on the effective date of this Act, but the provisions of this Act

24 concerning the salary or compensation of the judges of the Orphans' Court for Howard

25 County shall take effect at the beginning of the next following term of office.

26 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 27 October 1, 1998.
