- 1 (3) [practice] PRACTICE judging of livestock, dairy cattle, poultry, other 2 animals, agronomy crops, horticultural crops, or other farm products[,]; [organized] ORGANIZED visits to farms by school children, 4-H 4 clubs, FFA clubs, and others as part of their educational programs[,]; ORGANIZED VISITS FOR PURPOSES OF PARTICIPATING IN OR 6 OBSERVING HISTORICAL REENACTMENTS AS PART OF AN EDUCATIONAL OR 7 CULTURAL PROGRAM; and [viewing] OBSERVATION OF historical, archaeological, or scientific 8 (6)9 sites. 10 5-1104. 11 Except as specifically recognized by or provided in § 5-1106 of this subtitle, an 12 owner of land who either directly or indirectly invites or permits without charge 13 persons to use the property for any recreational or educational purpose or to cut 14 firewood for personal use does not by this action: 15 (1) Extend any assurance that the premises are safe for any purpose; 16 Confer upon the person the legal status of an invitee or licensee to (2) whom a duty of care is owed; or 17 18 Assume responsibility for or incur liability as a result of any injury to 19 the person or property caused by an act of omission of the person.
- 20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 21 October 1, 1998.
